For most of that time it was known as the Studio City Golf and Tennis Center, a fitting name because it seemed to be loved and enjoyed it. A place so diverse in its unique appeal that it's not unusual to find accomplished golfers and tennis players at the other.

I moved my family to this area 14 years ago, partly because its mature trees and greens provided a peaceful oasis to urbanized. We are not a family of great means, but my own two sons have, since grade school, been able to pay the forehands. Visits often included a stop at the tiny grill where, for years, a kind Korean-American couple served up gyoza and 24 years old, and I hope they are not the last generation of young people to enjoy the pleasures of this neighborhood filled with historic significance, those places become a kind of living history lesson in themselves.
