Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the March 18, 2021 actions of the City Planning Commission approving the proposed General Plan amendments to the Hollywood Community Plan, Framework Element and Mobility Element.

The proposed General Plan amendments to the Hollywood Community Plan, and related amendments to the Framework Element and Mobility Element, are submitted to you for your recommendation, which is to be forwarded to the City Council as specified by Section 11.5.6 of the Los Angeles Municipal Code.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed General Plan amendments, land use designations, and zone changes, including adoption of the new Hillside Construction Regulation (HCR) Supplemental Use District Ordinance, the Community Plan Implementation Overlay (CPIO) District Ordinance, the Ordinance to Amend the Vermont/Western Transit Oriented District Specific Plan and the Ordinance to Amend the Hollywood Redevelopment Plan, will be consistent with the City's General Plan.

Your action is requested on the proposed General Plan amendments as specified by Section 11.5.6 of the Los Angeles Municipal Code. The zone changes will be transmitted to you following the City Council's action.

RECOMMENDATION

That the Mayor:

1. Concur in the attached action of the City Planning Commission relative to its approval of the proposed General Plan amendments for the Hollywood Community Plan; and
2. Recommend that the City Council adopt the attached Findings of the City Planning Commission relative to the General Plan amendments; and
3. Recommend that the City Council adopt, by Resolution, the General Plan amendments to the Hollywood Community Plan, Citywide General Plan Framework Element, and Mobility Element, as shown in the attached Exhibits C and E; and
4. Recommend that the City Council direct staff to revise the Hollywood Community Plan, the Long Range Land Use Diagram of the Citywide General Plan Framework Element, and the Mobility Map of the Mobility Element, in accordance with this action.

HOLLYWOOD COMMUNITY PLAN UPDATE; CPC-2016-1450-CPU

Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the March 18, 2021 actions of the City Planning Commission approving the proposed General Plan amendments to the Hollywood Community Plan, Citywide General Plan Framework Element and Mobility Element. The City Planning Commission also approved the adoption of the Hillside Construction Regulation (HCR) Supplemental Use District Ordinance, the Community Plan Implementation Overlay (CPIO) Ordinance, the Ordinance to Amend the Vermont/Western Transit Oriented District Specific Plan and the Ordinance to Amend the Hollywood Redevelopment Plan, and the requested zoning actions to effect changes of zone and height districts as set forth in the attached exhibits.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed General Plan amendments, land use designations, and zone changes will be consistent with the City's General Plan.

The proposed General Plan amendments were submitted to the Mayor whose recommendation will be forwarded to you as specified in Section 11.5.6 of the Los Angeles Municipal Code.

RECOMMENDATION

That the City Council:

1. Concur in the attached action of the City Planning Commission relative to its approval of the proposed General Plan amendments for the Hollywood Community Plan; and

2. Adopt the attached Findings of the City Planning Commission as the Findings of the City Council; and
3. Adopt, by Resolution, the General Plan amendments to the Hollywood Community Plan, Citywide General Plan Framework Element and Mobility Element, as set forth in the attached Exhibits C and E; and
4. Adopt the Ordinances to effect changes of zone and height district, and establish the Hollywood Community Plan Implementation Overlay (CPIO) District and the Hillside Construction Regulation (HCR) Supplemental Use District, and adopt the Ordinances to amend the Vermont/Western Transit Oriented District Specific Plan and the Hollywood Redevelopment Plan, as set forth in the attached Exhibits D and F; and
5. Direct staff to revise the Hollywood Community Plan, the Long Range Land Use Diagram of the Citywide General Plan Framework Element and the Mobility Map of the Mobility Element, and update the appropriate zoning maps in accordance with this action; and
6. Adopt the Resolution in Exhibit C to Certify the Environmental Impact Report ENV-2016-1451-EIR; and
7. Adopt the Resolution in Exhibit C to adopt the EIR Findings, Statement of Overriding Considerations, and a Mitigation Monitoring Program.
