SUBJECT: REQUEST FOR PAYMENT OF REWARD FOR DR NO. 17-13-06548

RECOMMENDED ACTIONS

1. That the Board of Police Commissioners (Board) REVIEW and APPROVE the attached Application for Special Reward Payment.
2. That the Board TRANSMIT to the Mayor and City Council the Application for Special Reward Payment for review and approval.

DISCUSSION

It is requested that the Board approve and transmit to the City Council the recommendation that an approved reward offer be paid to Claimants A & B in the sum of \$50,000. The Claimants provided information that was vital to the arrest and conviction of the person responsible for the Fatal Hit and Run of Bobby James Arnold, Traffic Collision Report, DR No.17-13-06548. It is requested that the \$50,000 reward be divided among the two Claimants.

On February 11, 2017, Bobby James Arnold was crossing Broadway within the crosswalk at 49th Street when a dark-colored Nissan Quest mini-van struck him. The driver (suspect) fled the scene without rendering aid or identifying himself or herself. Los Angeles Fire Department paramedics responded to the location and transported Arnold to a local hospital, where he succumbed to his injuries.

The announcement of the reward by Central Traffic Division Detective Johnny Meneses, Serial No. 25980, resulted in the Claimants coming forward and providing crucial information that led to the identity of the driver, Teresa Vergara Amigon. The driver was arrested and convicted for California Vehicle Code Section 20001(b)(2), Felony Hit and Run, and was sentenced to five years in state prison on August 21, 2018, Superior Court Case, BA463279. The information provided by the Claimants was vital in the arrest and conviction of the suspect making the Claimants eligible to receive payment.

It is the opinion of the investigating detectives and the Deputy District Attorney assigned to this case that the information provided by Claimants A & B was vital in the arrest and conviction of the suspect, Teresa Vergara Amigon. Central Traffic Division Detectives believe the Claimants have met the requirements and are eligible to receive the reward payment.

Elderly Man Dies from Hit and Run Collision NR17049im

Los Angeles: The Los Angeles Police Department Central Traffic Division detectives are asking for the public's help in providing any information that would lead to the identification and arrest of the suspect involved in a hit and run collision that fatally injured a 69-year-old man.

Today, Saturday, February 11, 2017, at 6:20 a.m., a vehicle traveling south on Broadway Boulevard collided with a 69-year-old man, the elderly man was crossing westbound on Broadway Boulevard at 49th Street within the marked crosswalk when he was struck. The driver, failed to remain at the scene, identify himself, and render assistance as required by law.

Los Angeles Fire Department paramedics responded to the location and transported the elderly man to a local hospital, where he succumbed to his injuries. The vehicle description is pending review of nearby surveillance videos. The identity of the elderly man is pending verification from the Los Angeles County Coroner's Office.

On April 15, 2015, the City Council amended the Los Angeles Administrative Code and created a Hit and Run Reward Program Trust Fund. A reward of up to \$50,000 is available to community members who provide information leading to the offender's identification, apprehension, and conviction or resolution through a civil compromise.
