The number of unvaccinated is certainly higher in the city than the County due to a higher minority population which have lower vaccination rates. Are you willing to discriminate against the poor who can least afford reduced access to basic necessities?

Compelling anyone to take any current Covid-19 vaccine violates federal and state law

Four key concerns:

* First, while the vaccine remains unapproved by the CDC and authorized only for emergency use, federal law forbids mandating it, in accordance with the Nuremberg Code of 1947;

* Second, the Americans with Disabilities Act proscribes, punishes and penalizes those who invasively inquire into someone's medical status and then treat those individuals differently based on their medical status, as the many AIDS related cases of decades ago fully attest; and

* Third, international law, Constitutional law, specific statutes and the common law of torts all forbid conditioning access upon coerced, invasive medical examinations and treatment, unless the mandating person can fully provide objective, scientifically validated evidence of the threat from the employee and how no practicable alternative could possibly suffice to mitigate such supposed public health threat and still perform the necessary essentials of employment.

At the outset, consider the "problem" being "solved" by vaccination mandates: dangerous or deadly transmission, by the asymptomatic or pre-symptomatic employee, in the business setting. Yet even government official Mr. Fauci admits, as scientific studies affirm, asymptomatic transmission is "very rare."

Symptomatic individuals already self-isolate by staying home when sick, just like we've always done to prevent the spread of flu or a cold. **The previously infected are better protected than the vaccinated, so why aren't they exempted?** Anyone who suspects they may be infected can get tested.

† Because some cases have multiple vaccinations and symptoms, a single case can account for multiple entries in this table. This is the reason why the Total Count is greater than 595622 (the number of cases found), and the Total Percentage is greater than 100.

Israeli data is more complete than the US data and has vaccinated more of their population. The table below from the **Israel Ministry of Health** shows **no difference in rate of Covid cases among the vaccinated and unvaccinated, so effectiveness of the vaccine to prevent infection is almost non-existent**. Example 89% of 50-59 year olds are vaccinated and 88% of the Covid cases are vaccinated individuals.

Comments for Public Posting: I am writing in opposition to the Covid-19 Vaccination requirement ordinance that would mandate proof of Covid-19 vaccination or proof of a negative PCR test in order to enter indoor venues (restaurants, stores, gyms, theaters, other businesses, etc). This imposition of the Covid-19 "passport" would essentially destroy businesses in your city by forcing them to incur liability if they mistakenly admit customers who are not vaccinated/do not have a negative test/ are missing a mask. You will likely ensure that visitors as well as residents will choose to use Big-tech sources such as AMAZON to supply their needs at the expense of the brick and mortar businesses in your area. If these Covid-19 vaccination verification systems are mandated in order to enter your city businesses, this will create significant social and racial equity issues by unfairly impacting low income people who would have trouble traveling to another County to get what they need if they cannot get the experimental Covid shots due to health issues, religious issues, and/or other reasons outside of their control. In an era of "inclusivity," a Covid-19 vaccine "passport" which this City Council is hoping to mandate would create a two-tier society in which persons would have to choose between the unknown adverse effects of these experimental shots or face being excluded from indoor businesses to obtain food, medicines, or simply social interaction. The fact that the Covid-19 vaccines do not prevent the contraction of the virus and its variants, nor the transmission of the virus for those vaccinated decimates the reasons for imposing such vaccines in LA City. In fact, the clinical trial study designs for COVID vaccines did not address transmission, but merely addressed reducing symptoms, as explained in the materials they submitted to the FDA to obtain Emergency Use Authorization. Such mandates do not address the fact that many in the population have survived Covid-19 and have greater immunity that won't require booster shots in 6 months unlike the those vaccinated with these experimental Covid shots. This City Council must not forget that Covid vaccines HAVE NO LONG-TERM SAFETY TESTING thanks to the warp speed at which the FDA has been pressured to approve these Covid shots - this has made it impossible to determine what these vaccines will do to humans in the medium-to long-term. The pharmaceutical companies have no liability for creating and rushing clinical trials on these Covid-19 vaccines (and others like them). So who would be the target of adverse results from these experimental Covid vaccines? The businesses, employers, and LA City which impose such mandates would be ones to face the lawsuits. The City has already made itself vulnerable to liability by imposing these experimental Covid vaccines upon its employees even though the Covid shots were only approved for Emergency Use (which means it is ILLEGAL for LA City to force an employee to get the shot in order to keep her City job.) To impose these tyrannical Covid-19 vaccine requirements to attend indoor venues in LA City would create the "1984 Orwellian" society in which the government invades individuals' HIPAA privacy rights and tramples the constitutional rights of visitors and citizens of LA City. You certainly will lose long-trusted employees in which the City has invested hours and money to train how to perform valuable city jobs. You have already undermined the safety of LA City by mandating these experimental vaccines upon police and fire employees who will likely leave for better opportunities in other cities or states.
