Comments for Public Posting: I strongly oppose the Covid-19 Vaccination Requirement Ordinance. The CDC recently announced that the vaccinated transmit the virus just as easily as the unvaccinated. Both the vaccinated and unvaccinated carry similar viral loads and can equally transmit the Delta virus. A growing percentage of people in Los Angeles who are vaccinated are getting the Delta variant. The percentage keeps climbing, from 20% of all identified cases in June, to 30% end of July; August is not reported yet, but it's on a steady climb. Vaccination alone won't stop the rise of new variants and in fact could push the evolution of strains that evade their protection. The emergence of a partially or fully vaccine-resistant strain and its eventual establishment appears inevitable. Contrary to Pfizer assumptions, mRNA does not stay in muscles, and S-protein travels into bloodstream (11 subjects out of 13 had S-protein in blood, according to Pfizer's own biodistribution study for Japanese Government). S-protein circulating in the blood is the reason for blood clots, bleeding, and myocardia. From their own literature, sperm counts are lowered post vaccination, and there have been many reports of miscarriages after receiving the vaccinations. A study out of Israel shows that Israelis who were vaccinated were 6.72 times more likely to get infected after the shot than after natural infection (those who had recovered from Covid.) Those who are vaccinated make antibodies against the spike proteins only, whereas the naturally infected make antibodies against many parts of the virus. Safer alternatives exist, such as ivermectin and hydroxychloroquine. Naturally boosting the immune system is the greatest defense, including a healthy diet and exercise, supplemented by Vitamin C, D, A, zinc, and glutathione. And, practically speaking, a vaccine requirement ordinance would unfairly impact businesses; businesses would incur the liability if they admit customers who are not vaccinated, and if they don't, they would be at a competitive disadvantage with those businesses that do. Also, if markets and other convenience stores require proof of vaccination, it would unfairly impact low income people would have trouble traveling to another county to get what they need. Comments for Public Posting: I know that you are facing an important decision now, and I trust that you don't take this decision lightly. You have a responsibility for this City, its people, its economy and the public health. And all of our civil rights, as well. After all, the facts need to be right, or else the legislation will just turn out to be a move for the City Council to enforce an apartheid system of medical segregation, which will in effect vilify people who choose to have autonomy over their bodies, and take care of their health in a different way, often under doctor's orders. This is America. We all can feel in our bones what it is like to be discriminated against – as Blacks, Latinos, gays, Asians, Armenians, Jews, and new immigrants. I am certain that you don't want to make this move without good reason. ***Therefore, I think it is important that we address the basis for the argument that the unvaccinated are causing the high rate of disease, and thus should be removed from public places for the greater good of the public health. ***When we take a hard look at the facts – as opposed to the narrative we are being presented – we can see that there are serious problems with the logic that the unvaccinated are ill and are symptomless carriers, while the vaccinated are well and safe to be around. Please consider this information and take it in. ***In so doing, you will see that you must reconsider the problem you are solving, and vote No on Vaccine Requirement Ordinance #21-0878*** (All of the following was found online. For lack of time, I have not dug out all the sources.) The commonly used PCR test was stated by its inventor to not be valid, because it shows as positive when you have Influenza A & B & adenovirus. Even the FDA has admitted the PCR test is not valid. It was not based on the SARS-CoV2 virus. But it's still being used. The PCR test has not even been used in a valid way – it is run at 45 cycles (akin to exponential magnification) – driving up the numbers of who was & is ill, to show many false positives. This has caused us to overstate the numbers of unvaccinated ill throughout the time of COVID. Those who have tested positive have been called "cases", instead of what is normal in health, that a "case" is a person who has observable symptoms. Also overstating the numbers of unvaccinated ill. Now people who are vaccinated are not tested routinely (with the stated presumption that they are well), while there are situations where the unvaccinated are tested regularly (with presumption that only they might be ill). However, the CDC has said outright that the vaccines don't prevent COVID, they just reduce the severity of illness. (Note: the drug Ivermectin will do that more safely.) If the vaccinated are given the PCR test, it is run at 28 cycles (which is more valid), while the unvaccinated are given a PCR test run at 45 cycles (much higher rate of false positives). Again overstating the numbers of unvaccinated ill. (Source: CDC) The CDC is only tracking those who had the shot if they are admitted to hospital or die. If treated as outpatient, they are not included in the number of people ill with COVID.
