Comments for Public Posting: Dear City Council Member, I urge you to vote NO on the Covid 19 Vaccination Requirement Ordinance. I am not an Anti-Vaxer. This so-called "approval" gives yet another false sense of security to the American people, when in fact, the FDA approved vaccine is called Comirnaty. The FDA decreed that the Pfizer-BioNTech vaccine under the EUA should remain unlicensed but can be used "interchangeably" (pg 2, footnote 8) with the newly licensed Comirnaty product. A very deceptive tactic, and dangerous.
