Comments for Public Posting: As a County employee who has worked throughout the pandemic and with close contact with the public until now, the idea of a vaccine passport is upsetting. DOCUMENTED FACTS ABOUT VACCINATIONS

The VAERS website of the CDC shows 13,068 deaths, and 54,142 hospitalizations, 72,699 urgent care as of August 13, 2021.(6) Some reports say that information on the VAERS website is significantly under reporting.

Although the media tells us that 97% of new cases are among the unvaccinated, many new cases we hear about are among the fully vaccinated. Interesting news report from other countries...

- In the UK, 45% of those hospitalized with Covid are partially or fully vaccinated.(7)

PFIZER COVID-19 VACCINE - Summary of the efficacy/safety profile sourced from FDA.gov and Pfizer clinical trials March 11, 2021

- Will the vaccine stop COVID spread? "UNKNOWN: A vaccine must be introduced before the peak of reported cases to have a significant impact on the pandemic course."
- Will the vaccine affect fertility? "UNKNOWN: Has not been studied but there are strong enough concerns that studies are being proposed. Sperm counts are lowered post vaccination."(11)
- How long will the vaccine last? "UNKNOWN: We only have data to support 2 months."

S-protein circulating in blood is the reason for blood clots, bleeding, myocardia. (12)

IVERMECTIN

Ivermectin is on the WHO's List of Essential Medicines. Ivermectin fights [21 viruses](#), including SARS-CoV-2, the cause of Covid-19. A single dose reduced the viral load of SARS-CoV-2 in cells by 99.8% in 24 hours and 99.98% in 48 hours, according to [a June 2020 study published in the journal Antiviral Research](#). (13) Out of four billion doses administered since 1998, there have been only 28 cases of serious neurological adverse events, according to an article published this year in the American Journal of Therapeutics. (14)

After 6 months of vaccination and a year of research, a number of red signals should be alerting the *would-be* vaccinated and health authorities:

1. **Wandering nanoparticles:** The lipid nanoparticles, the carriers of the mRNA, were supposed to remain in the muscle, but ended up broadly distributed throughout the [body](#), notably in the [ovaries](#), the [liver](#) and possibly the bone marrow.
2. **Anaphylactic PEG:** A number of concerns had been raised regarding the novel use of [PEG adjuvant](#). Notably, prior research had raised the risk of [cardiac anaphylaxis at second injection](#).
3. **Sensitive locations:** ACE-2 receptors susceptible to binding to the spike protein are highly expressed in the endothelial cells of highly sensitive areas, such as the brain, the heart, the lungs, the liver and both male and female reproductive systems.
4. **Toxic circulating spikes:** The [spike proteins](#) induced by mRNA/DNA [vaccines](#) have been [shown](#) to be [pathogenic](#), and highly inflammatory, notably because of the similarity of a spike sequence to that of [Staphylococcal Enterotoxin B](#). It has also been found to be directly [causing blood clots](#) through [platelet activation](#). One researcher said, “Our findings show that the SARS-CoV-2 spike protein causes lung injury even without the presence of an intact virus”.
5. **BBB disruption:** A recent study highlights the risk of disruption of the [blood-brain barrier](#), a fundamental filter mechanism to protect the brain. The spike protein has also been found to [cross the BBB](#) and [create inflammation](#) in the brain.
6. **High adverse events:** Even though most likely [under-reported](#), the overall number of serious adverse events versus other traditional vaccines remains very high. The [6,000+ deaths](#) seen [in the US] in six months exceed all the vaccine-related deaths in 30 years. This is quite disquieting, and tends to confirm the aforementioned alarms.
7. **Children more at risk:** The Covid-19 vaccines seem to be more harmful to children and teens, notably with a [growing number](#) of [myocarditis](#) events. The fact that vaccine doses are not adjusted for body weight is notably a cause for concern given the discovery of circulating nanoparticles and spike toxicity.

These are essentially just the short-term effects of these novel vaccines. There is no long-term clinical data regarding the implications of these vaccines, notably regarding autoreactive antibodies (antibodies that target one’s own body creating autoimmune diseases). (15)

Comments for Public Posting: Hello Council Members I understand you want to protect Angelinos and keep people from spreading and transmitting corona virus. However this vaccine is not capable of that. 1. Rochelle Walensky, head of the CDC, stated that the vaccine is not holding up against this Delta Variant. 2. The vaccinated have 251x more virus and are pre-symptomatic spreaders based on recent Oxford study 3. The Pfizer and Moderna reports to the FDA to receive their emergency use states in section 8 of unknown data: no evidence for stopping infection or transmission. 4. Dr. Hoffe from Canada states 62% of his patients have micro clots – a ticking time bomb. • Other countries like Iceland and Denmark are seeing the failure of these vaccines as they have high vaccination rates and their hospitals are full. They are going back to sound strategies of protecting the elderly and vulnerable and letting the very young and healthy freely live their lives in order to reach herd immunity. • This vaccine is not allowing for herd immunity according to Gert Van den Bossche, developer of vaccines for GAVI, because indiscriminate vaccination during an outbreak puts pressure on the virus to produce the variants you are trying to prevent. In addition, it takes your innate immunity which is broad and narrows it to be so specific, it can't handle the variants its creating.
