Comments for Public Posting: Dear LA City Council members, I am writing in opposition to ANY future measures to "show papers" and "proof" of vaccination status for our county. Such guidelines are unconstitutional, discriminatory, and dangerous to society. Requiring citizens to display their private medical records to merit access to good and services will result in a two-tiered social system. A community divided into those who relinquish their right to privacy, and religious and bodily autonomy for the privilege of access, and those that hold liberty foremost and are consequently denied access. A society of haves and have nots, or, more specifically, those who have liberty without access or those who have access without liberty. This outcome would be an inexcusable atrocity we must be intentful on avoiding. The Constitution of the United States was designed to protect the people from inhumane and unjust acts being committed against them by their government. It is our duty to maintain those same standards of protocol in our local government. As requiring vaccination verification is prohibited by international treaties, federal and state laws, then it stands to reason that it should not be permitted by our county, public or private entities as well. To deny one access to education, purchasing food or other essential goods and services if they do not display vaccination verification amounts to coercion and results in segregation. It is also in violation of CA GOV Code 51 which states that, "All persons within the jurisdiction of this state are free and equal, and no matter what their sex, race, color, religion, ancestry, national origin, disability, medical condition, genetic information, marital status, sexual orientation, citizenship, primary language, or immigration status are entitled to the full and equal accommodations, advantages, facilities, privileges, or services in all business establishments of every kind whatsoever." These rights are mirrored in Title II of the Civil Rights Act of 1964: Injunctive Relief Against Discrimination in Places of Public Accommodation SEC. 201. (a) "All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, and privileges, advantages, and accommodations of any place of public accommodation, as defined in this section, without discrimination or segregation on the ground of race, color, religion, or national origin." See also SEC. 202: "All persons shall be entitled to be free, at any establishment or place, from

discrimination or segregation of any kind on the ground of race, color, religion, or national origin, if such discrimination or segregation is or purports to be required by any law, statute, ordinance, regulation, rule, or order of a State or any agency or political subdivision thereof.” To coerce a person into submitting to a medical procedure in order to gain access to goods and services is the definitive opposite of consent. A presidency of bodily autonomy and the right to refuse medical care is well established by rulings of our Supreme Court. Two pertinent examples: First, in 1982, the U.S. Supreme Court tersely traced the history of the right to refuse medical treatment: Under the common law of torts, the right to refuse any medical treatment emerged from the doctrines of trespass and battery Superintendent of Belchertown State School v. Saikewicz. Second, Matter of Farrell in 1987 finds that “Generally, a competent informed patient’s interest in freedom from nonconsensual invasion of her bodily integrity would outweigh any state interest.” It is in the best interest of the people of Los Angeles to prohibit vaccine passports or any future calls for vaccine status disclosure which violate medical privacy, result in coercion, and lead to discrimination. The SARS-COV-2 virus has rattled us all, but we must not barter our liberties to assuage our fears. Such shortsighted actions made in haste are far harder to unravel than if their consequences were initially weighed rationally and with respect to legal and historical precedence in addition to common decency and fairness. Comments for Public Posting: A vaccine passport system would create a two-class medial apartheid system, immunity caste system, and would further the gap in equality, especially disproportionate numbers from some of our most vulnerable communities, such as people who are low-income, have disabilities, or are homeless, as well as more than 40 percent of people over age 65, including immigrant communities and communities of color who are already subject to over-policing and surveillance Requiring COVID-19 vaccine passports for taking part in everyday life such as, but not limited to, attending a sporting event, patronizing a restaurant, or going to a movie theater would create two classes of citizens based on vaccination; and it's illegal according to the UNRUH CIVIL RIGHTS ACT. Other treatments and therapies are available as an alternative Any form of coercion via medical mandates, vaccine Passports, digital QR code or any verification to show proof of vaccination violates California Health and Safety codes: 24171 "right of individuals to determine what is done to their own bodies." and 24172(J) "Be given the opportunity to decide to consent or not to consent to a medical experiment without the intervention of any element of force, fraud, deceit, duress, coercion, or undue influence on the subject's decision." Universally accepted codes of medical ethics, including the Nuremberg Code and the Declaration of Helsinki, absolutely prohibit any form of coercion to make individuals participate in a medical experiment. All currently available COVID-19 is authorized for emergency use, regardless if emergency use status changes, or becomes FDA approved, therefore it must remain voluntary under the Nuremberg Trial Codes; the Declaration of Helsinki, and California law. County Department of Public Health and CHHS acknowledges there are many instances where an individual, along with their doctor, decide that being vaccinated may be unsafe; and a vaccine passport or verification system discriminates against those who cannot receive the vaccine. Vaccine passports, or arbitrary state and county guidelines, do not take into consideration the large number of citizens who have contracted and recovered from COVID-19 and are therefore naturally immune as Covid survivors. It will not stop at COVID-19 vaccines. Once in place, it will allow the coercion of any and all vaccines, booster shots, or "so-called" requirements.
