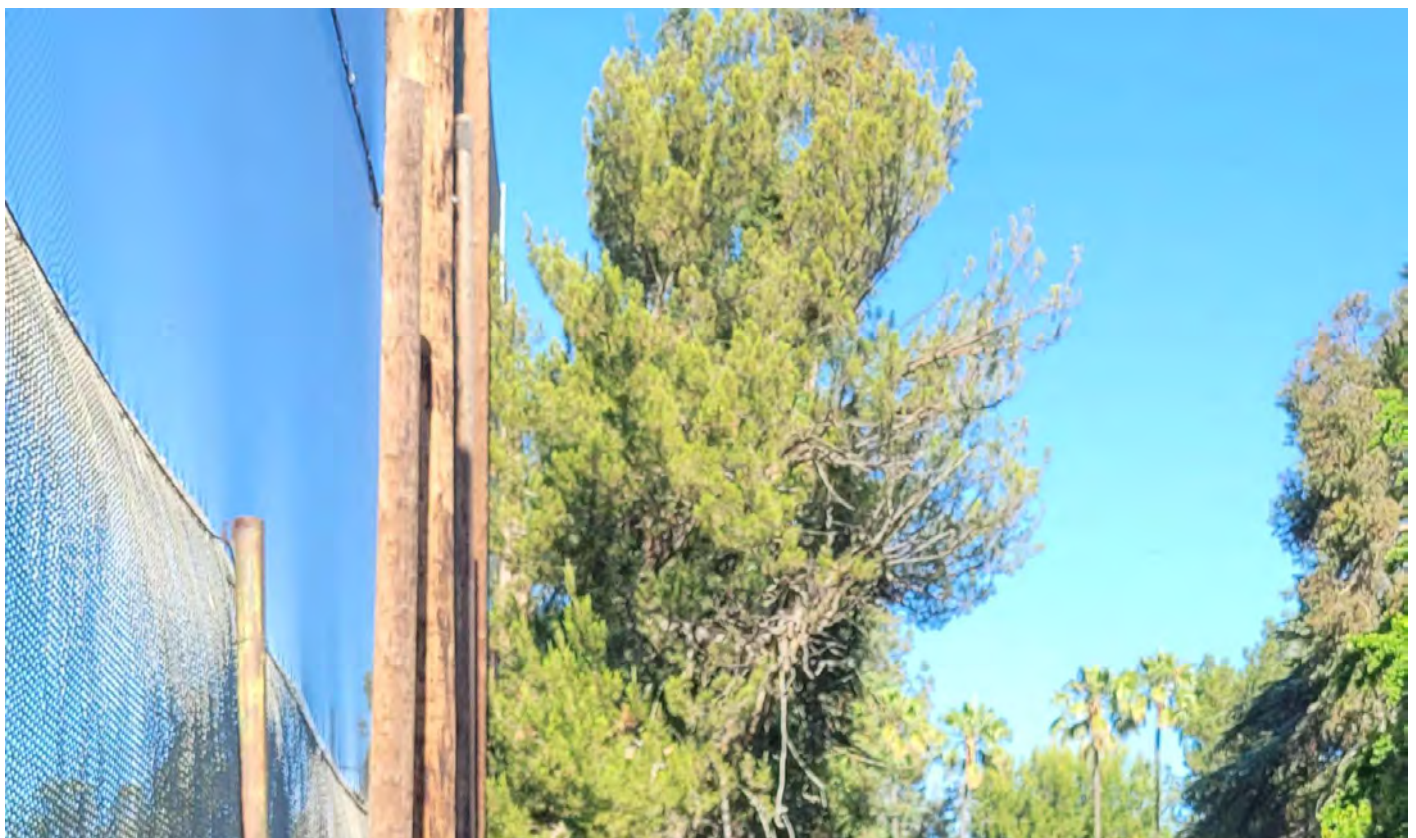

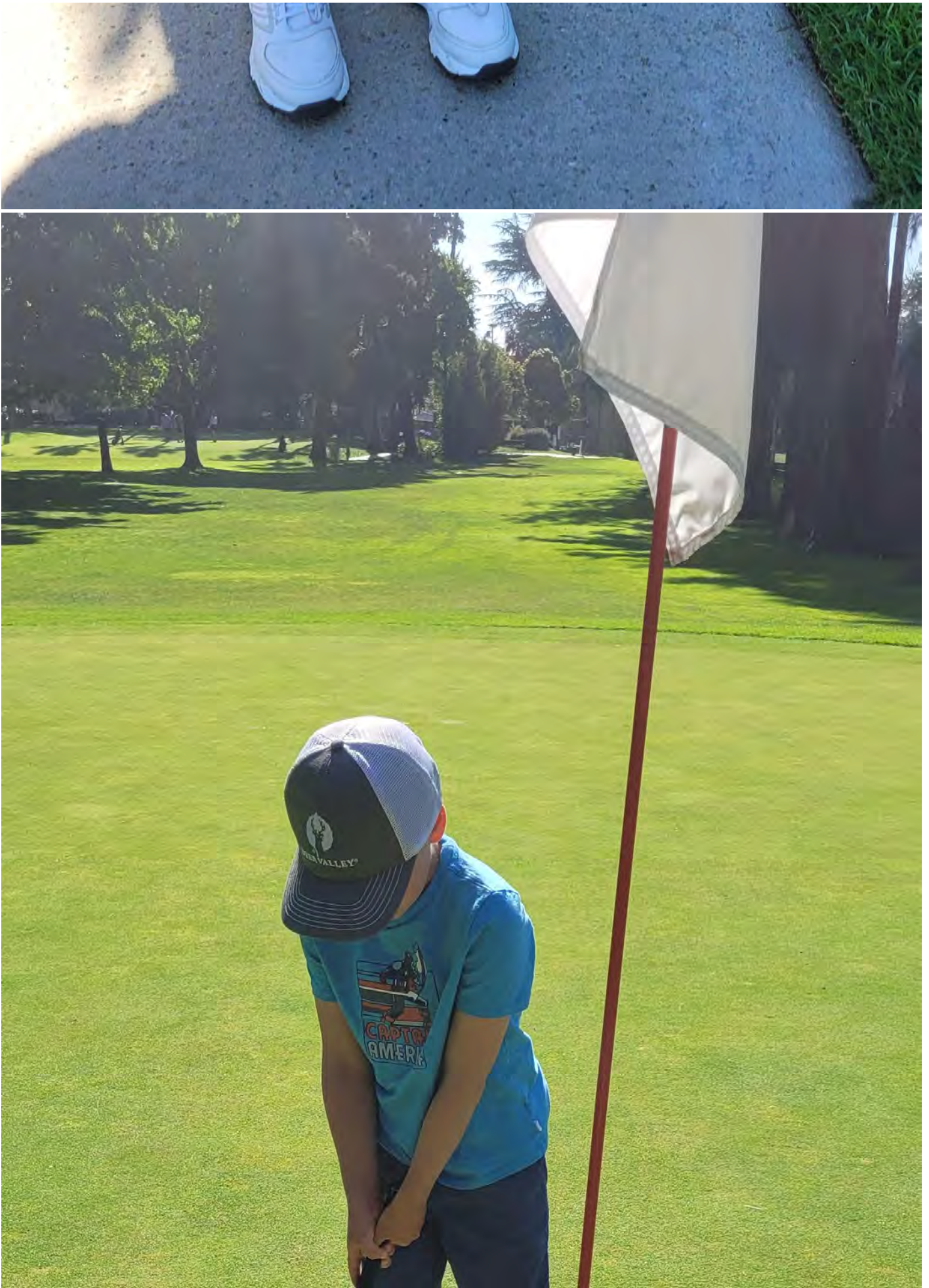

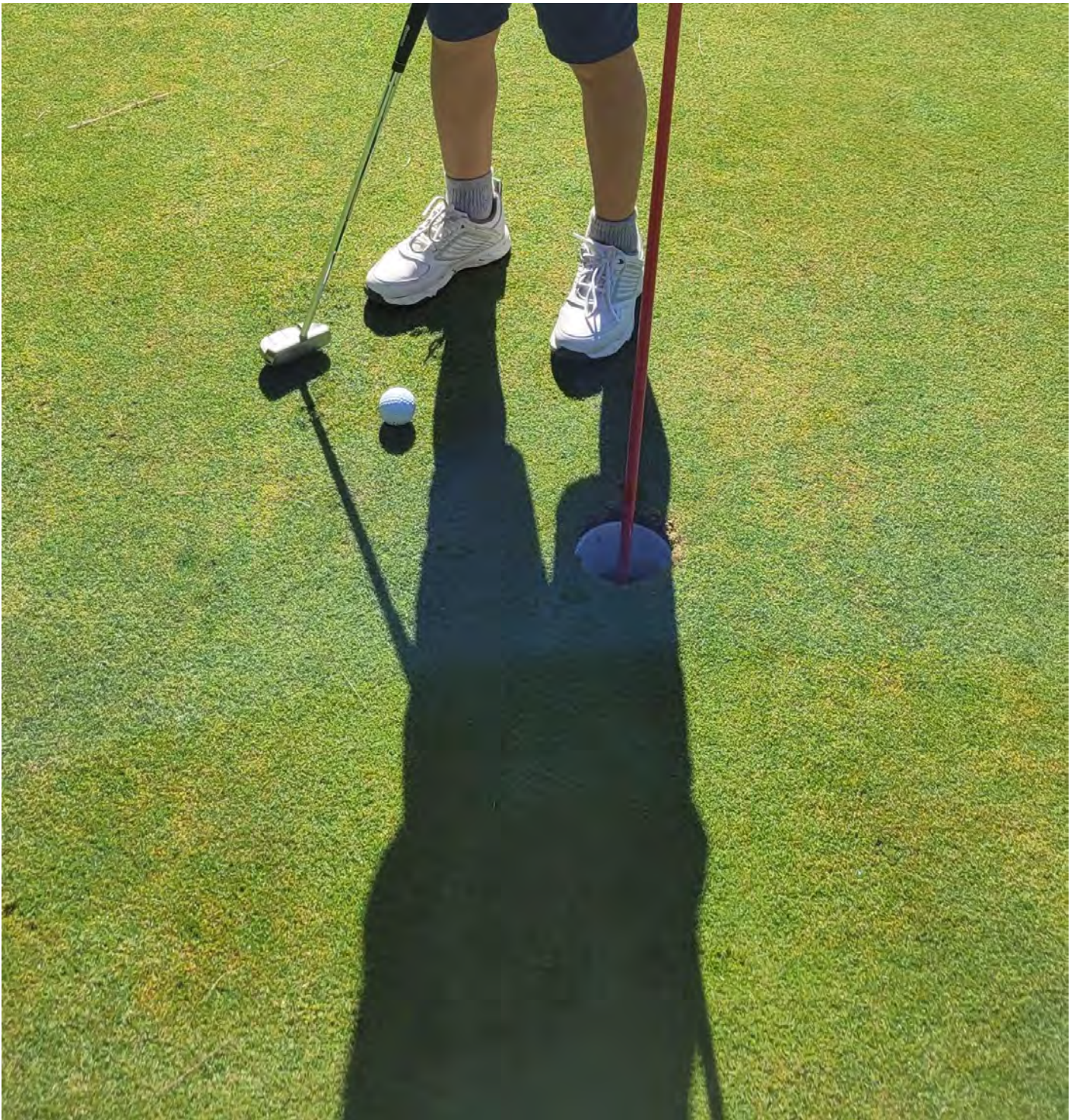
Not to mention, my 7 year old son learned to golf there, and it would leave us all heart broken.

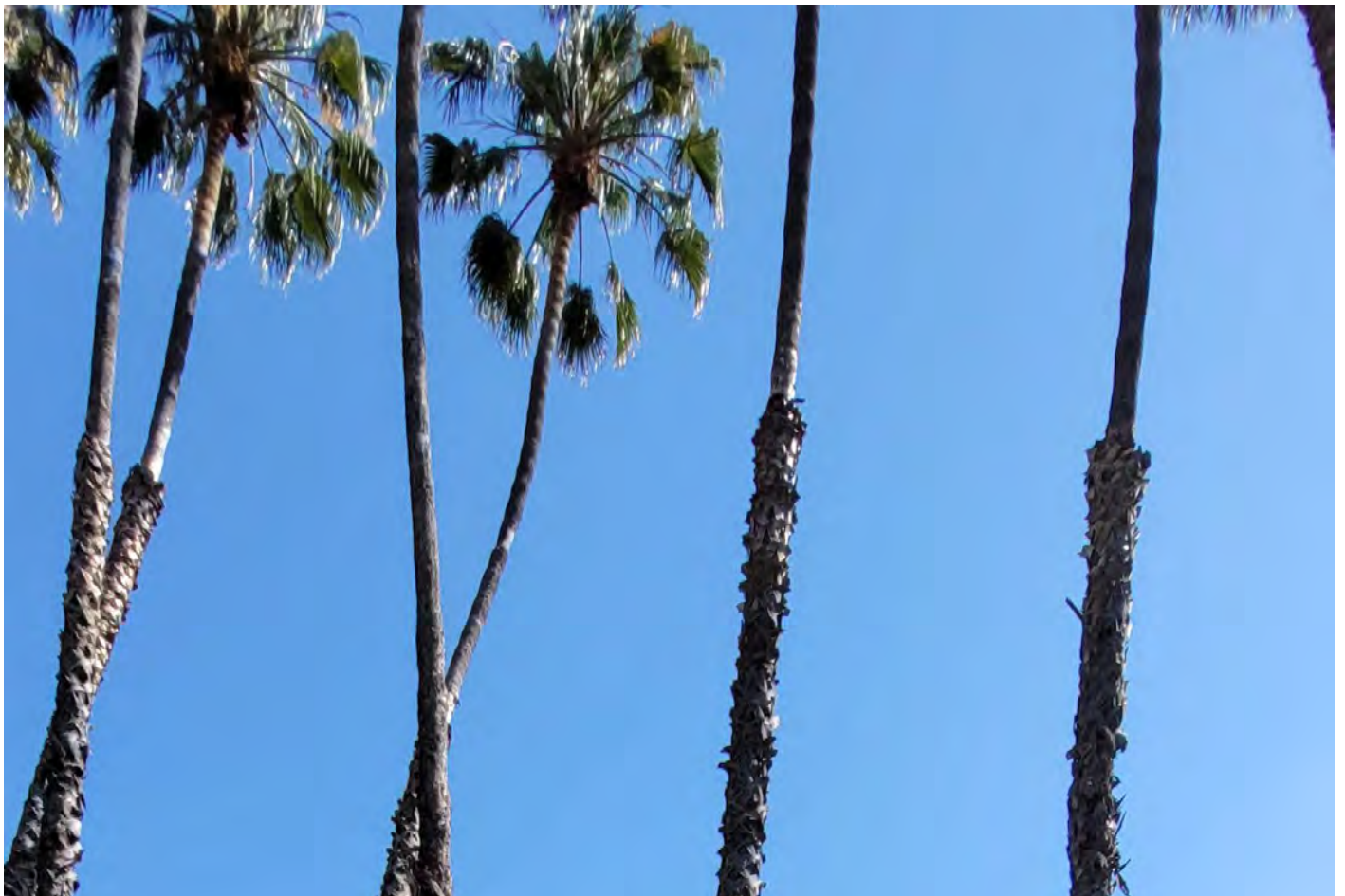
