

ORDINANCE NO. _____

An ordinance dedicating, accepting and establishing certain real property owned by the City of Los Angeles as part of Bundy Drive south of West Missouri Avenue, all public streets of said City.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that an easement for public street purposes over the following described real property owned by the City be, and same is hereby dedicated, accepted and established as part Bundy Drive south of West Missouri Avenue, all public streets of said City.

THAT PORTION OF BLOCK 24 OF PACIFIC FARMS, IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 1, PAGES 43 AND 44 OF MAPS IN THE OFFICE OF THE COUNTY RECORDER OF LOS ANGELES COUNTY, LYING SOUTHWESTERLY AND WESTERLY OF THE FOLLOWING DESCRIBED LINE:

BEGINNING AT THE INTERSECTION OF THE NORTHWESTERLY LINE OF PARCEL A OF PARCEL MAP L.A. No 3084 IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP FILED IN BOOK 66, PAGES 33 AND 34 OF PARCEL MAPS IN THE OFFICE OF THE COUNTY RECORDER OF LOS ANGELES COUNTY, WITH A LINE PARALLEL WITH AND DISTANT 13.00 FEET NORTHEASTERLY MEASURED AT RIGHT ANGLES FROM THE SOUTHWESTERLY LINE OF SAID BLOCK; THENCE NORTHWESTERLY ALONG SAID PARALLEL LINE TO A POINT DISTANT 15.00 FEET SOUTHEASTERLY MEASURED ALONG SAID PARALLEL LINE FROM THE NORTHWESTERLY LINE OF SAID BLOCK; THENCE, NORTHERLY IN A DIRECT LINE TO A POINT ON SAID NORTHWESTERLY LINE DISTANT 15.00 FEET NORTHEASTERLY MEASURED ALONG SAID NORTHWESTERLY LINE FROM SAID PARALLEL LINE.

Sec. 2. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication.


