We urge City Council Members to support this ordinance.

The CHNSC is comprised of a dedicated cadre of salon workers and owners, and approximately 30 public health and environmental advocates and allies in government agencies. The CHNSC's mission is to improve the health, safety and rights of the nail and beauty care workforce to achieve a healthier, more sustainable, and just industry. In California, 80% of the nail salon workforce are people of color and nearly 70% of California's 440,000 manicurists and cosmetologists are Vietnamese, most of whom are refugees, immigrant women, and low-wage workers—the communities that are being heavily impacted by COVID-19. In California, the largest percentage of nail salon workers live and work in Los Angeles County. The pandemic has had a devastating impact on the nail salon industry and impacted employers and workers alike.

While COVID-19 rates continue to increase, it is a major risk for many communities, such as the nail salon workforce. As a grantee of the LA County COVID-19 Community Equity Fund Project, we have conducted outreach to hundreds of nail salon workers and employers through the region. As outbreaks and new cases still continue, especially with the Delta variant, COVID-19 is a major concern in the workplace. It is imperative for employers to continue to take steps to reduce the risk of COVID-19 transmission among their workers and clients. Personal care workers are significantly people of color, from low-income, immigrant and refugee communities across the state.

In March 2020, personal care services were recognized by Governor Newsom as being a high-risk industry; they were among the first ordered to be shut down by the Governor and nail salons remained closed for a good part of the year and had initially reopened at limited capacity. Due to these closures and restrictions, this industry has been particularly hit hard by the pandemic.
