## **NOTICE TO APPELLANT(S), APPLICANT(S), AND INTERESTED PARTIES**

You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing **telephonically** on **Tuesday, October 19, 2021** at approximately **2:00 PM**, or soon thereafter, to consider the following: Categorical Exemption from the California Environmental Quality Act (CEQA) pursuant to Article 19, Section 15332, Class 32 of the CEQA Guidelines, and related CEQA findings; report from the Department of City Planning, and an Appeal filed by Enrique Velasquez, Coalition for An Equitable Westlake/MacArthur Park, from the Director of Planning's determination in approving a Categorical Exemption, No. ENV-2020-4390-CE, as the environmental clearance for a proposed qualifying Tier 3 Transit Oriented Communities project with a total of 80 dwelling units, including 8 units reserved for Extremely Low Income Household occupancy for a period of 55 years, along with the following two Additional Incentives: a) Setback (Side and Rear) to utilize any or all of the yard requirements for the RAS3 Zone per Los Angeles Municipal Code (LAMC) Section 12.10.5; and, b) Open Space to permit a 25 percent reduction in open space per LAMC Section 12.22.A.25(f)(6); for the properties located at 730 South Vermont Avenue and 3077 West Leeward Avenue.
