PARKING VIOLATION TRUST FUND 853

Dear Honorable Members:

The Los Angeles Department of Transportation (LADOT) requested an escheatment of \$292,671.32 from their "Parking Violation Trust Fund 853" (Fund No. 853) to the City General Fund. This money was received by LADOT for security deposits and has remained unclaimed for at least three years and therefore is eligible for transfer in accordance with State of California Government Code Section 50050-50055, the notification requirements of the City of Los Angeles Administrative Code, and current state law. LADOT has since revised the Escheatment amount to \$ 126,227.74 as per LADOT "Report of Claims Against Monies Available to be Escheated" and reported that claims totaling \$73.00 have been processed, which reduces the monies available for escheat to \$ 126,154.74.

BACKGROUND

The State of California Government Code Section 50050-50055 provides that any money remaining unclaimed in the City Treasury for three years or more may become the property of the City after publication of a notice, provided that within the specified period of time, no verified complaint seeking to recover all or a designated part of the money is filed in a court of competent jurisdiction. Further, Sections 11.33-11.35 of the Los Angeles Administrative Code allow the legislative body to transfer these monies to the City's General Fund.

Attached herewith is LADOT's request to escheat monies from Fund No. 853 dated April 19, 2021, the Office of the City Clerk's proof of publication advertisements dated June 3, 2021, and the subsequent notices and publications executed on June 10, 2021. In accordance with Council File No. 12-1436, notice of these unclaimed monies was also posted on LADOT's website.

These notices stated that on July 30, 2021, funds received from January 1, 2016 through December 31, 2017 would become property of the City. As of the aforementioned dates, a total of \$73.00 was claimed and an adjustment made by LADOT for \$126,227.74 thereby reducing the amount available to escheat to \$ 126,154.74.

RECOMMENDED ACTION

In accordance with the authority of the State Government Code and City of Los Angeles Administrative Code, it is recommended that City Council, subject to the approval of the Mayor, should:

1. INSTRUCT the Los Angeles Department of Transportation and the City Treasurer to process a sum of \$ 126,154.74 from the Parking Violation Trust Fund 853: and
2. INSTRUCT the Controller to TRANSFER all identified eligible monies to the City's General Fund.

The City of Los Angeles Department of Transportation (LADOT) submitted an escheatment request to the Office of Finance on April 19, 2021. The request was intended to escheat outstanding checks issued in 2016 and 2017, those of which remained unclaimed for more than three years in accordance with the State of California Government Code Section 50050-50055. The subsequent notices and publications were executed by the Office of Finance and the City Clerk Office. While adjusting the final escheated amount based on processed claims, LADOT concluded that an administrative oversight occurred when retrieving the list of 3,084 outstanding checks for publication. This oversight occurred due to staffing shortages as a result of the Separation Incentive Program (SIP). The 2017 checks were omitted from the list, and checks issued in 2015, which were escheated previously, were inadvertently included in the list.

LADOT has since taken corrective measures to avoid future administrative oversight. LADOT has adjusted the escheatment period to 2016 and the escheat amount from \$292,671.32 to \$126,227.74. LADOT has reported that a claim of \$73.00 has been processed, which reduces the monies available for escheat to \$126,154.74. The escheatment for checks issued in 2017 will be submitted in the next request by LADOT.



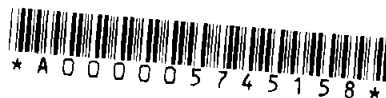
