

PERSONNEL, AUDITS, AND ANIMAL WELFARE COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to establishing the salary for the new non-represented class of Executive Director, Youth Development Department (YDD; Class Code 9226).

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the following ORDINANCES dated August 31, 2021 and approved by the City Attorney as to form and legality to:
 - a. Amend Los Angeles Administrative Code (LAAC) Section 4.321, pertaining to general manager positions, to include the newly established classification of Executive Director, YDD (Class Code 9226).
 - b. Amend Schedule "A" of LAAC Section 4.61 to include and provide a salary for the new, non-represented classification of Executive Director, YDD.
2. AUTHORIZE the Controller and the City Administrative Officer (CAO) to correct any clerical errors, or, if approved by the City Attorney, any technical errors in the above Ordinances.

Fiscal Impact Statement: The CAO reports that the General Fund is not impacted by this action. Funds have been budgeted in the 2021-2022 Adopted Budget for the YDD.

Community Impact Statement: None submitted.

Summary:

On October 20, 2021, your Committee considered a September 21, 2021 CAO report, two September 1, 2021 City Attorney reports, and two Ordinances relative to establishing the salary for the new non-represented class of Executive Director, YDD (Class Code 9226). According to the CAO, on September 8, 2021, the Executive Employee Relations Committee approved the Mayor's recommendations to establish the salary for the new non-represented class of Executive Director, YDD at Salary Range M-7 (\$143,132-\$253,817). Accordingly, the Ordinances submitted herein establish the salary for and add the class of Executive Director, YDD to the list of General Manager Positions in LAAC Sections 4.61 and 4.321, respectively. This new class has been adopted by the Civil Service Commission and created at the request of the City Council in the establishment of the new YDD. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the recommendations contained in the CAO report and detailed above. This matter is now submitted to Council for its consideration.
