GENERAL PLAN SAFETY ELEMENT UPDATE; CPC-2021-5499-GPA, ENV-2020-6762-EIR

Pursuant to the provisions of Section 551 and 555 of the City Charter, transmitted herewith is the October 14, 2021 actions of the City Planning Commission approving the update to the Safety Element of the General Plan.

Adopt the Resolution in Attachment 4 to certify the EIR, adopt EIR Findings and a Statement of Overriding Considerations, and adopt a Mitigation Monitoring Program, when presented; or in the alternative, if the Resolution to certify the EIR has been adopted in a prior action by the City Council and the Housing Element Update and/or the Safety Element Update and/or the Health Element Update has been approved, find, as applicable, that the Housing Element Update and/or the Safety Element Update and/or the Health Element Update, was considered in the EIR and pursuant to CEQA Guidelines
