The Glassell Park Improvement Association (GPIA) has been active in the Glassell Park community for over 50 years and during those years we have taken an active role in supporting or opposing numerous projects on behalf of our residents.

We are writing to voice our opposition to the proposed Los Angeles Zoo 20 Year Vision Plan and our support for Alternative 1.

Griffith Park, while not within Glassell Park, is close to us and a valuable resource for Glassell Park residents both for recreational purposes and as nature preserve. Ever since it was dedicated, the City and park advocates have had to balance the dual needs of preserving the park as natural space and as developed park space for local residents. The current zoo structure falls within that balance.

Alternative 1 would help bring the Zoo up to 21st century standards and provide much needed infrastructure improvements for the well-being of the Zoo's animals and the research that is done there. However, the overly ambitious "20 Year Vision Plan", with increased traffic and large parking and entertainment structures, would destroy precious native woodland habitat, and turn the Zoo into an expensive theme park totally out of line with the scale and purpose of Griffith Park as a city park and nature preserve.
