Comments for Public Posting: Please include Reynier Village in district CD-5. Rationale: - community and residents reside in CD-5 - LAPD, LAFD and USPS are in CD-5 - existing CD-5 office is closest in proximity and also these existing boundaries most closely align with the needs of Reynier Village - Robertson Blvd currently splits CD-5 and CD-10 and this division has created confusion and hardships for the community and residents in that we cannot successfully manage the needs of the neighborhood having to deal with two council districts to get anything done. CD-5 shares the most common issues and services and as such Reynier Village should be included in CD-5. -unifying and moving the district border to La Cienega is a more natural boundary and would create better unification of neighborhoods and allow for increased business and residential improvement - push CD-10 to start on at La Cienega by doing so it will allow for less confusion between districts, streamline processes for council members and align neighborhoods to the needs of the residents.

Comments for Public Posting: Hello, I've lived in Reynier Village (the far west side CD-10) for 28 years. I feel very strongly that Reynier Village would be much better served by being redistricted to CD-5 for the following reasons: - the majority of our community (South Robertson Neighborhood Council and residents) are in CD-5. - our LA Police station (West LA) and our US Post Office is in CD-5. - the CD-5 office is very close by, and more accessible to us. - Robertson Blvd. IS SPLIT BETWEEN CD-5 AND CD -10. For decades, this has created significant hardships for residents and businesses to unify and improve the boulevard. As Robertson Blvd. is a major artery with significant traffic and commerce problems, any City improvements on Robertson Blvd. must be dealt with by 2 different council offices. This always creates barriers to getting anything done (if at all) in a timely and proper manner. Robertson Blvd. is The Heart of the South Robertson community. Important issues concerning our neighborhood are generally always centered around Robertson Blvd. and being split between two council districts is always inefficient and very problematic. - the South Robertson Neighborhood Council always has to confer with, and get special reports from two council offices. Any special events they want to hold on Robertson Blvd. or ask for improvements on Robertson Blvd. has to be sent to (and agreed by) two separate council offices. While I am not on the board of the NC (or able to speak on their behalf), I do believe the NC would also be better served if all residents were under CD-5. - redistricting criteria #5 states that: "Districts shall be drawn utilizing natural boundaries and streets and to encourage geographic compactness to the extent feasible". La Cienega Blvd. IS THE natural boundary for CD 5, as CD-5 already extends to La Cienega Blvd. (just north of Reynier Village) at 18th Street. If Reynier Village was redistricted by its natural boundary, La Cienega, (instead of Robertson Blvd.), its residents would be more unified geographically and for reasons stated above, much better served by CD-5. - the 2020 Census tract 2697.00, which includes Reynier Village and a portion of Castle Heights, is split between CD 10 and CD 5. - as Reynier Village is a small area at the far west end of CD-10 and already located immediately adjacent to CD-5, it would be a very minor adjustment to the borders, and follow a more natural line by having the cut off at La Cienega
