## R E S O L U T I O N

WHEREAS, portions of Lot 37, and portions of Lots 81 through 87 inclusive, as shown on the map of Sunny Side Park, as per map filed in Book 6, Page 8, of Maps, in the office of the County Recorder of Los Angeles County, were offered for dedication for public street and alley purposes by that certain "Irrevocable Offer to Dedicate," recorded on December 22, 2020, as Document No. 20201709071, of Official Records, in the office of the County Recorder of Los Angeles County, the dedication to be completed at such time as the City Council shall accept the same for public street and alley purposes; and
