RE: Redistricting 2021

A 2011 politically-motivated attack on CD8 removed almost all of its main economic engines from the last redistricting process. Its constituents have faced continuing serious socio-economic challenges since. CD8 is the only remaining majority black voter district in the city. Because of this acrimonious action by the City Council, CD8 has some of the lowest employment figures in the city, and is absolutely last in tax base amongst districts.

“Part of the redistricting process is the equitable distribution of economic assets. These give the representative a voice for the interests and concerns of their constituents and the ability to leverage benefits for the community. For example, ten years ago, the last redistricting process stripped City Council District Eight of its economic assets, namely Exposition Park (home of the Olympic games), including the Coliseum, the California African American Museum (CAAM), USC, and Leimert Park.” Council District 8

Now, via the current redistricting, is the opportunity to reverse the wrong of the last process, providing more opportunity, services, and equity for the CD8 community. It is vital to the redistricting process that the council allocates CD8 reasonable access to the city’s economic engines. Those assets were a part of the district for decades. Therefore, the most practical and fair solution is to return USC and Exposition Park to CD8.

When CD9 took these two assets, it also had viable economic assets such as the Convention Center, Staples Center, L.A. Live, and the Ritz-Carlton complex. CD8’s asset of any significance is the decaying Crenshaw Mall. The imbalance is clear, and even more so when comparing other districts. Should CD9 receive an accompanying boost, it can return some downtown assets taken from it, adjacent to its existing grouping. The downtown 14th District is extremely asset-heavy, loaded via political favoritism toward a now-indicted Councilmember.

At the very least, the council must reach a compromise regarding USC and Exposition Park. The independent redistricting commission first voted to return both assets to CD8. The submitted map accommodated the request of the Neighborhood Council, which contains these assets, to be consolidated together in CD8. After a political play, the council reversed the decision in favor of an alleged compromise. Was there actually a compromise? The fair one would return the USC to CD8, leaving Exposition Park in CD9. Yet in the Redistricting Commission's final report, they moved Exposition Park to CD8 and left USC for CD9.

When beginning to finalize the process, the City Council Ad Hoc Redistricting Committee, which unfairly includes the Council members from CD9 & CD14, took action to eliminate even the mediocre compromise in the Redistricting Commission map. The Ad Hoc Committee returned Exposition Park to CD 9. Again their Redistricting map leaves CD 8 with only the Crenshaw Mall. The City Council's political maneuvering is contrary to the independently appointed Redistricting Commission's recommendations and clearly politically motivated. Politically motivated efforts like this reinforce the systemic disadvantage repeatedly applied to this community.

“According to 2020 Census Data in Council District Eight, 52% of the voting-age public are African Americans. It is the only African American Community of Interest in the City of Los Angeles. It is where we have made our homes and raised our families for generations — where Black voters can collectively elect candidates of their choice who can articulate their needs. As a literal and figurative backbone of the city, Black LA is a power player with significant contributions across business and creative sectors stamping its unique worldview on everything from art and architecture to politics and fashion. This is all evidenced by the global desire and consumption of our culture.” Marqueece Harris-Dawson

To leave the only black-majority district without assets, via a Council action that retracts the one small concession of returning USC and Exposition Park, is a clear indication that equity is NOT a primary concern of the City Council. The Council's decision has civil rights implications and must be corrected. CD8 must have USC and Exposition Park returned to provide the community with reasonable economic opportunity and fair districting.

Normandie is a natural boundary between CD-1 and CD-10; HH/NH is physically separated from CD-1 by a cemetery, crematorium, industrial land, Normandie Park, Loyola High School, and the St. Sophia complex, all community assets but huge masses of non-residential land. - HH/NH has long, close ties to the rest of Historic West Adams to the south and west as well as a shared interest in its public assets, e.g. the Ray Charles Studio/Museum, the Underground Museum, the Debbie Allen Dance Academy, HPOZ resources, etc. HH/NH has no meaningful ties to CD-1. - HH/NH has strong working relationships with CD-10 staff. - Moving HH/NH to CD-1 would divide the neighborhood council area as well as the Harvard Heights HPOZ. - Coordinating public activity involving both council district offices will be much more cumbersome and, frequently, prohibitive (i.e., street closures for public events, general city services, public/private cleanup operations, HPOZ board appointments, etc.)
