Re: <u>Reappropriation of Funds for Fiscal Year 2021-22 for the FY 2019 (Council File</u> <u>No. 19-0695) and FY 2020 (Council File No. 20-1156) Urban Areas Security</u> <u>Initiative (UASI) Grant Programs</u>

Dear Honorable Members:

Transmitted herewith for City Council consideration are proposed contracting authorities and reappropriation of funds for Fiscal Year 2021-22 for the FY 2019 and FY 2020 Urban Areas Security Initiative (UASI) grant awards from the United States Department of Homeland Security (DHS). The UASI projects outlined in this report were approved previously and the request is to continue to fund these projects through the end of the grant performance periods.

# UASI 19 (Council File No. 19-0695) Reappropriation

On March 17, 2020, the City Council accepted the FY19 UASI grant in the amount of \$56,236,000 with a grant performance period from September 1, 2019 to May 31, 2022.

## Los Angeles Fire Department

The Mayor's Office is requesting a total of \$195,354.25 be appropriated to the LAFD and that \$56,767.89 be appropriated from the LAFD salary and fringe accounts in the previous fiscal year to various LAFD equipment projects. All position authorities for LAFD were included in the Personnel Authority Resolution (PAR) (Council File No. 20-1700). The grant-funded positions are fully funded through the FY 2019 UASI grant program.

## Management & Administration

The Mayor's Office requests the authority to reappropriate \$1,453,098.78 for staffing management and administration costs.

# UASI 20 (Council File No. 20-1156) Reappropriation

On March 24, 2021, the City Council accepted the FY20 UASI grant in the amount of \$56,236,000 with a grant performance period from September 1, 2020 to May 31, 2023.

# Los Angeles Fire Department

The Mayor's Office is requesting a total of \$2,747,207.43 be appropriated to the LAFD and that \$336,100.00 be appropriated from the LAFD salary and fringe accounts in the previous fiscal year to various LAFD equipment projects. All position authorities for LAFD were included in the Personnel Authority Resolution (PAR) (Council File No. 20-1700). The grant-funded positions are fully funded through the FY 2020 UASI grant program.

# Recommendations

It is therefore requested that the City Council:

- 1. Authorize the Mayor, or designee, to:
  - a. Modify the existing grant budget or the Fiscal Year (FY) 2019 Urban Areas Security Initiative (UASI) grant (C.F. 19-0695) and Fiscal Year (FY) 2020 Urban Areas Security Initiative (UASI) grant (C.F. 20-1156) by reallocating funds between projects and conducting the necessary fiscal transfers;
  - Prepare Controller instructions for any technical adjustments, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions;
- 2. Authorize the Controller to:
  - a. Transfer and create new appropriations within **Fund 63G/46, UASI 19** (Council File No. 19-0695) as follows:
