DRAFT ORDINANCE AMENDING SECTIONS 2.23, 2.24, 2.25 AND 2.26 OF THE LOS ANGELES ADMINISTRATIVE CODE TO ESTABLISH NEW COUNCIL DISTRICTS FOR THE CITY OF LOS ANGELES

#### Honorable Members:

As requested by the City Council, this Office has prepared and now transmits for your consideration the enclosed draft ordinance amending provisions of the Los Angeles Administrative Code to establish new Council districts for the City of Los Angeles as a result of the decennial redistricting process. The ordinance has been approved as to form and legality.

On November 9, 2021, the City Council adopted a draft redistricting map of new Council districts and instructed the Bureau of Engineering to prepare the metes and bounds descriptions of the new districts. The City Council also requested the City Attorney's Office to utilize the metes and bounds descriptions to prepare and transmit an ordinance establishing the new Council districts. The City Council adopted the final redistricting map of Council districts on November 23, and scheduled consideration of the final redistricting ordinance for December 1.

The Bureau of Engineering worked in conjunction with the Chief Legislative Analyst's Office to prepare the metes and bounds descriptions for the new Council

district boundaries. As requested, we have utilized these metes and bounds descriptions to prepare the enclosed draft ordinance establishing new Council districts for the City of Los Angeles. We also have attached a copy of the map of the new Council districts for ease of reference.

Pursuant to Council Rule 38, we discussed the draft ordinance with the Bureau of Engineering and the Chief Legislative Analyst's Office.

The provisions of this ordinance shall become effective upon publication in conformance with Los Angeles City Charter Section 252(h).
