On behalf of 3.3 million AARP members in California and nearly 119,000 members in the City of Los Angeles, I write in support of Council File 21-1469 Sidewalk Maintenance and Repair Program.
AARP is a nonprofit, nonpartisan organization dedicated to empowering people to choose how they live as they age. We work to strengthen communities by advocating on issues that matter most to older adults and their families. The City of Los Angeles is experiencing a sizeable increase in its older adult population, an expected nationwide trend as baby boomers age. According to the LA Controller's Office, over 764,000 residents of the City of Los Angeles are considered older adults (age 60+) and this population is projected to exceed 1 million by 2030 when nearly one in four Angelenos will be over the age of 60. Comments for Public Posting: Regarding: Council File 21-1469 Street Maintenance and Repair Program We are Community Organizers from Communities Actively Living Independent and Free in Downtown Los Angeles. We are an Independent Living Center that provides services to people with disabilities in over 50 zip codes. We are also an Aging and Disability Resource Connection that provides services to seniors and the disabled throughout LA County. We wish to express our support for the LA City Controller's office report "Repairing LA's Broken Sidewalk Strategy". Our Independent Living Center was one of the plaintiffs in the Willits Case Settlement. We are frustrated with the slow response in repairing the sidewalks. Many of the people we serve are still stuck in their homes because the sidewalks are not accessible. Most sidewalks remain unchanged. We have sidewalks that can best be described as dangerous. Wheelchairs can literally tip over. People with walkers and canes can trip over the broken pavements. The only alternative people have is to take their lives into their own hands by walking or rolling into the streets and risk getting hit by a car. Given this situation, many people remain stuck in their homes unable to fully participate in their own communities. We support the following: 1. Funding a professional inventory of the sidewalks 2. Eliminating the outdated policy of fix and release 3. Involving our mobility and transportation experts at LADOT in the entire sidewalk/crosswalk program. 4.
