SUBJECT: OFFICIAL POLICE GARAGE CONTRACT RENEWAL

RECOMMENDATIONS

1. That the Board APPROVE and TRANSMIT to the City Council, the Executive Director's report recommending renewal of the Towing and Storage Agreement for Official Police Garage (OPG), for Service Area 5, Seventh Street Garage, Inc.
2. That the Board request AUTHORIZATION from the City Council for the President of the Board of Police Commissioners, or a designee, to negotiate and execute the renewal agreements with the affected OPG.

DISCUSSION

Los Angeles Municipal Code Section 80.77.4(B)(5) states that "each OPG contract awarded pursuant to this section shall provide for an option to renew the contract for an additional five-year period subject to approval by the City Council."

The Commanding Officer of Commission Investigation Division (CID) has conducted a review of the OPG eligible for renewal and has determined that Seventh Street Garage, Inc. has satisfactorily performed the work required by the contract in compliance with federal, state and local laws.

A review of the complaint history for Seventh Street Garage, Inc. revealed no serious violations or patterns of misconduct.
