According to our research and the CDC the cost of alcohol to LA city and county is 2 billion dollars a year and 6 people die each day from health and violent harms associated with alcohol each day. Alcohol sales give a negative return to LA City residents. This ordinance is subsidizing the restaurant industry at tax payers' expense and ignores public health.
