RE: Recommendations for Los Angeles Justice Fund Phase II for Immigration Services

Founded in 1986 the Coalition for Humane Immigrant Rights (CHIRLA) is a California leader, with national impact, made up of diverse immigrant families and individuals who act as agents of social change to achieve a world with freedom of mobility, full human rights, and true participatory democracy, fully inclusive of refugees and immigrants. CHIRLA prides itself in our work to serve the immigrant community through civic engagement, community education, organizing, advocacy at the forefronts of local, state, and federal government, and the provision of legal immigration services.

On behalf of CHIRLA, I am writing to follow up on our previous letters and urge the Immigrant Affairs, Civil Rights, and Equity Committee to adopt the following program recommendations outlined in the CLA's report:

Option 1A: Adopt the proposed Immigrant Legal Services framework, in partnership with LA County, CCF, and Weingart, and instruct the CAO and CLA to report on the transfer of existing LAJF cases to the new program.

Option 2B: Authorize city funds allocated in the FY 2021-22 Adopted Budget to be used for financing existing LAJF cases and new cases under the new Immigrant Legal Services framework.

Option 3B: Adopt a merit-blind approach where criminal history is not considered as eligibility criteria for participating in the new program.

Since its launch in 2017, the LAJF pilot program demonstrated the power of a public-private partnership to expand the safety net available to the one-third of Angelenos who identify as immigrants. According to an analysis by the USC Dornsife Equity Research Institute, as of January 2021 LAJF grantees reported at least 2,047 legal screenings and provided representation to 568 cases throughout L.A. City and County. The LAJF

pilot program far exceeded its initial goals of bolstering existing removal defense efforts, increasing capacity, and enhancing and expanding access to legal services.

Justice and dignity for immigrants is fundamental to our recovery and our ability to live into our vision of anti-racism as a city. Through March 31, 2020, LAJF provided legal representation that resulted in 62% positive outcomes, compared to only 23% of immigrants without counsel nationally who were able to obtain immigration relief.¹ Everyone at risk of deportation deserves a fair day in court even if they cannot afford an attorney.

CHIRLA respectfully urges the City of Los Angeles Council, the Immigrant Affairs, Civil Rights, and Equity Committee, and the Budget and Finance Committee to build on their commitment to immigrant communities by funding a universal representation model (as outlined in the CLA report under Option 1A, Option 2B, and Option 3B) that engages the realities of those navigating the intersections of complex bureaucratic immigration processes and the legacy of systemic racism and xenophobia within the criminal justice system. We applaud your leadership in uplifting the intersectional needs of immigrant communities.
