Dear Honorable Councilmembers,

The [Reusable LA Coalition \(RULA\)](#) commends the collaborative leadership between the ECCEJR Committee and LASAN on plastic pollution reduction and its serious focus on solving the City's waste problems. The recommended policies outlined in the November 2021 report are far-reaching and comprehensive in scope. The policies outlined, particularly around source reduction and reusable foodware, will result in multifold benefits to both our environment and economy.

We respectfully submit the following comments in response to the determination in Table 3 of the "Report on Various Motions on the Reduction of Single-Use Plastics" (issued by LASAN and considered by the Energy, Climate Change, Environmental Justice, and River Committee on December 2, 2021). **We recommend that the City shift the policies requiring the use of reusable foodware for dine-in services and the fee on disposables from "longer term" to "short term." Implementation of both those policies would result in a clear reduction of disposable foodware production, disposal, and environmental litter, and thus would have a significant beneficial impact on the environment.**

***A majority of studies show that reuse is better across all environmental measures.***

Without question, the requirement of reusable utensils, dishes, cups, and other foodware for on-site dining is one of the simplest and most effective strategies suggested. The transition from **disposable to reusable foodware is a win for the environment, climate justice, and small businesses.** This has been documented by an overwhelming majority of Life Cycle Analyses (LCAs) on the topic. Several recent reviews of the LCAs which considered disposable vs. reusable options have found this to be true.


Notably, the [2020 UCLA Luskin Center](#) report commissioned by the County of Los Angeles, "Plastic Waste in Los Angeles County: Impacts, Recyclability, and the Potential for Alternatives in the Food Service Sector", concluded that "based on available information, increased usage of reusable ware in the Los Angeles County food service sector would likely be an unequivocal net benefit. Potential avenues for such a transition include more consistent usage of reusable items at dine-in food service locations..." The report considered the LCAs and concluded that "Across most environmental impact categories, existing research shows a consensus that a reusable food service product- given reasonable assumptions about its lifetime uses- will have a smaller footprint than disposable options...Even accounting for varying methodologies, reusable items result in lower lifetime impacts than disposables."<sup>1</sup>

The United Nations Environment Programme in [Single-Use Plastic Tableware and its Alternatives](#) has also reviewed 6 LCAs of disposable plastic versus reusable options. The key take-away of the report is that “...reusable tableware consistently outperforms single-use tableware in all the studies and across all environmental impact categories...”<sup>2</sup> The report advises policy makers to choose to replace disposable foodware with reusables.

Upstream’s 2021 report [Reuse Wins](#), reviewed 14 LCAs of reusables and a wide array of disposable materials. Below are some of the highlights from that report regarding the environmental benefits of reusable foodware.



**Reuse is a climate solution.** In 2019, approximately 530 billion disposable cups were used worldwide- 85 billion in the U.S. alone.<sup>3</sup> All reusable cups (ceramic, stainless steel, glass) have lower CO<sub>2</sub> footprints than the single-use options (paper, PET, EPS, PP, PLA, laminated cardboard) when reused.<sup>4</sup> Reusables must be used enough times to achieve their environmental benefit. Glass, stainless steel, and ceramic cups cups greenhouse gas emissions and energy impacts, for cups, ceramic is better than paper when used 10- 70 times,<sup>5</sup> and 100 times when including the lid and a sleeve.<sup>6</sup> Glass is better than paper when used 36 times.<sup>7</sup> Generally, experts consider stainless steel, glass, and ceramic cups all to be used 1,000 times or more.

For plates, a reusable porcelain plate has much lower climate impact than polystyrene, PLA / compostable plastic, and cellulose pulp, with the *plant-based options having the worst impacts overall*.<sup>8</sup> For clamshells, reusable polypropylene clamshells need to be used 14 times to outperform the bagasse (fiber-usually sugarcane pulp) clamshell,<sup>9</sup> and 3-39 times to outperform the expanded polystyrene clamshell.<sup>10</sup> With few studies of disposable versus reusable utensils. However, one study found that

reusable stainless steel spoons had to be used twice to result in the energy consumption of two polystyrene plastic spoons, and four times to result in the same energy impact as polypropylene.<sup>11</sup>

**Reuse and water consumption.** A majority of the time, reusables have a lower water footprint than disposables. The water consumption of disposable cups (paper, expanded polystyrene, and compostable fiber) from cradle to grave is significantly higher generally than reusable ceramic<sup>12</sup> and glass<sup>13</sup> cups. Stainless steel cups are on par with paper cups for lifecycle water consumption.<sup>14</sup> The water used in growing bio-based plastics makes them the least favorable option.

However, reusables consume more water at restaurants (i.e. in the consumption phase) due to ware-washing. In a Starbucks study, ceramic reusable cups reduced the lifecycle water usage by 64% when they replaced paper cups. This was with older, less efficient dishwashers than are typically used today.<sup>15</sup> In a more recent study, 500 paper cups consumed nearly 370 gallons of water, versus one ceramic cup which required 53 gallons of water when used 500 times.<sup>16</sup> Newer more efficient commercial dishwashers that are typically in use today can significantly reduce the water consumption in food service operations.

### **Reuse saves food business operators money.**

We believe that the reordering of these elements between "short term" and "longer term" policy strategies may result in more immediate action to reduce or eliminate the negative environmental impacts of disposable foodware items, and thus the realization of substantial beneficial environmental impacts. Through these measures we can meet targets outlined in the Green New Deal including increasing landfill diversion rate to 90% by 2025 and reducing municipal solid waste generation per capita by at least 15% by 2030 including phasing out single-use plastics by 2028.

Furthermore, we recommend this action be considered immediately not only due to the aforementioned environmental benefits, but also **because reuse on site has been shown to save businesses money**. The County of Los Angeles Board of Supervisors is currently considering moving forward with Reuse for Dine-in immediately and we recommend the City coordinate efforts with the County and follow suit on this regard, ReThink Disposable has demonstrated that California foodservice businesses *always save money when transitioning to reusables onsite (based on 166 case studies)*, on average \$3,000 to \$22,000 per year by transitioning to reuse onsite, while also reducing between 110,000 to 225,000 packaging items per business and 1,200 to 2,200 pounds of waste.<sup>17</sup> And the potential savings for business and local government from reduced waste to manage would be enormous.
