Comments for Public Posting: I have worked with community members to ensure that Westchester Park is safe for seniors and youth athletes. Although the tent encampments have been removed from Westchester Park, there are still many vehicles used as dwellings in the parking lots of the park. We have been informed by staff of our Council Member that these vehicles may not be towed because of the covid-related moratorium imposed by City Council in October 2020. In an effort to lift that moratorium, the Council referred the present motion to this committee. This motion is based on LAMC 80.69.4, which allows towing of oversized vehicles parked in violation of "no parking" signs posted. However, based on the language of the February 2022 DOT report for this motion, it appears the committee is combining this motion with council file with 20-0147-S7, which applies more widely. I support that, and I would ask that committee members ensure to this motion is applied widely so LAPD may begin to enforce, for example, the ordinance that applies to parking lots in parks. LAPD records show many service calls to those parking lots involving guns, assaults and more, in recent months. LA is a "park poor" city and Westchester Park is used by youth of all races and socioeconomic status who need a safe park. I also ask that members of this Committee move to re-enact the former Section 85.02, which has sunsetted. That ordinance authorized the citing and towing of vehicles used as dwellings that were parked between 9 p.m. and 6 a.m. on any residential street or at "any time within a one-block radius of any edge of a lot containing a park or a licensed school, preschool, or daycare facility." Without 85.02, there is no authority to tow the vehicles covered by that ordinance regardless of whether the moratorium is lifted.
