I am writing this letter in response to a notice of public hearing for Habibi cafe. I am part of a property management group with locations in Westwood and throughout Los Angeles.

One of our main attraction points for apartments within Westwood is Habibi cafe. Habibi cafe provides a diverse community which is rich in culture and social connection. The restaurant's late hours have given life to the city of Westwood and has allowed other businesses to open late giving more options for tenants. Knowing businesses are open at night is a real boost to the real estate market of Westwood.

Many international students and guests inquire about apartments and look to book in the area. This is largely due to Habibi cafe being the attraction of Westwood village. We see Habibi cafe has security and the staff is always friendly and helpful resolving issues in the community. People feel safe at Habibi cafe, more so than Beverly Hills of Hollywood. We have never had a complaint from any of our tenants regarding safety issues, noise complaints or general concerns and we are just a block over from Habibi cafe. Therefore, Habibi cafe is clearly not a nuisance.

Upon reading the concerns regarding Habibi cafe, it is clear the restrictions being requested will not fix the crime rate in Los Angeles and they should not be reprimanded for them either. The restrictions being requested would make their business more strict than donut shops down the block. The LAPD, LADBS, homeowners associations and zoning administration should be building the community for tenants and entrepreneurs not reducing foot traffic.

Imposing hour limitations on Habibi cafe will negatively affect the real estate market in Westwood village. 





My name is Saad Fathi, I am a representative of Habibi cafe. I addressed the zoning administrator in the previous public hearing. I informed the speakers of the public hearing that the limitations they would like to force on the business were too extreme. We offered a list of which ones seemed reasonable and which ones we could work on together, to which we received no compromise on. The concerns are arbitrary and capricious. We have a right to assemble our business as we wish so long as we are within the laws, which is what we have done. This should at the very least allow our restaurant to exist. It seems like the individuals calling for the public hearing are not open to listening or compromising.

Since this hearing references the land and use concerns we would like to address the aspect of business. Habibi cafe has been located in Westwood for the past 20 years and is known internationally. We bring diversification to the community with our marketing efforts. Our clients come from all over the world and include the royal family of Saudi Arabia, NBA and NFL players, musical artists, wealthy entrepreneurs and socialites. A business which can

reach this clientele is beneficial for any area or use of land.

Our customers extend throughout Westwood impacting many industries positively. Our late hours allow other businesses to open later and they can attest to that. In the last year alone we have had two businesses open next to us and across from us as our location gives Broxton Ave. more foot traffic. Therefore, there are more jobs and businesses within Westwood. Other than Broxton Ave. The rest of Westwood has had a significant decline in business and many places are still for lease. As a business we have managed to navigate through many storms and continue growing. The choices made by the committees responsible for Westwood have resulted in a decline in foot traffic and many businesses throughout Westwood have come to discuss this with us after hearing the overstepping restrictions suggested for Habibi Cafe.

Our use of the location boosts the economy within Westwood making us an asset. Our branding and marketing efforts introduce the elite communities to the city which pours down to the other businesses like local eateries such as Diddy Riese, Falafel inc

and Hibachi Papi. We also bring along many international students who wish to rent close by so they may engage in middle eastern social activities like Shisha and Ramadan dinners. Boosting the economy within Westwood, along with the residential real estate pours over to the commercial real estate side which we have increased as well.

Clearly Habibi Cafe is an asset to the community. This has been vouched for by individuals in Westwood who have provided statements for the record. We have read their statements and clearly they do not agree with the limitations being forced on Habibi cafe. The statements written are from the following industries within Westwood: real estate community, new businesses, businesses which existed before us, other eateries, Middle eastern owned businesses, tech industry, and even the local print shop.

The concerns regarding topics like crime are rational however, the conditions are irrational and extreme. Since the start of the pandemic many violent crimes have erupted throughout Los Angeles and several different parts of Westwood. The LAPD and City of Los Angeles hardly have control over the crime wave

we are experiencing, therefore, businesses should not be penalized for the unusual activity. To claim Habibi Cafe is responsible for the crimes throughout Westwood would be the equivalent of blaming the store and restaurants in Beverly hills for the crimes occurring within their city.

Please view the crime statistics we have submitted to the record as accurate evidence. I would like to note that the LAPD included a heavy stack of police reports regarding Habibi cafe. Many of the police reports include Habibi cafe staff members calling for help from LAPD to assist other locations in Westwood and transient issues. We should not be reprimanded for that especially when the response time from LAPD takes about 6 minutes. We have resorted to managing the transient issue ourselves in a calm manner. Many of the homeless throughout Westwood are familiar with the operators of Habibi cafe and listen when we mediate issues. I have even received cards which are still in the office from homeless people who I have helped. So we can't simply say Habibi cafe is the source of crime and the suggested restrictions are the holy grail solution.

The members calling for the public hearing really have not been considerate when drafted suggested restrictions for Habibi cafe. I am a businessman, I have been doing it all my life and it is what I know best. We would love to accept all the conditions the members are requesting but, unfortunately that would put any one out of business. They are arbitrary and capricious. They violate the constitution and restrict our right to assemble a business as we choose. They would tank the business if we followed that plan. This is why we reviewed the terms and suggested which ones we can accept and which would pose a harm to our operation. However, the members of the public hearing rejected our suggestions and proceeded with what they liked. Our branding efforts have attracted a trending wealth focused market which is young. It seems like the members of the public hearing and select small businesses in Westwood are opposed to this market. We are all equal and all deserve the right to enjoy Westwood and a majority of the businesses in Westwood agree with us.

We put in effort to boost the economy and encourage students. We have a lot of international students who study at the cafe and make Habibi

their home for traditional comforts. We offer student discounts, nurse and doctor discounts and we often work with any student organization which offers discounts for their groups. We recently did this with the Middle Eastern Student Association of UCLA. Habibi Cafe contributes a lot of benefits for students to make their day easier. We encourage bringing jobs to Westwood and contribute to education it however we can.

We are requesting the council review the information presented as we believe the many of the comments made and issues are personal attacks by people who do not favor me. I always wear colors, I'm always friendly and I like fashion. Clearly my choice in style, being Egyptian and having sharper features and having a beard cause many people to stereotype me as dangerous. This is truly unfair, members like Steve Sand who has personal disagreement with me, have used the city's resources to seek revenge by taking down a business I built. The city's resources should not be used for that purpose, I avoid contact with him as he instigates many issues with many business owners in Westwood.

Although this is a public hearing, none of our neighbors believe we are a nuisance except for a few business owners in Westwood who personally have an issue with me so we avoid each other or just have a simple hello and goodbye. As a matter of fact, many neighbors directly and afar wrote in to say we are not a nuisance. They don't have noise complaints, crime reports, problems with loitering or even issues with our staff. Please keep in mind these are our direct neighbors and within walking distance of the cafe. So how is it possible that so many concerns are coming from individuals beyond walking distance.

The plans being requested would tank any business even one like ours who has been successful for over 20 years. Why should we spend so much more capital to satisfy issues which are not our responsibility.

We see three sections which have concerns. First, the LAPD, who was blaming us for the crime increase within Westwood just a year ago. We informed the LAPD the crime rates have increased and that is everywhere, so we are not promoting

criminal activity. According to the data you can see there are so many crimes within Westwood alone that have nothing to do with Habibi cafe. Also we are located on one of the most famous blocks in Westwood village, obviously if there are crimes in Westwood village it will be on this block statistically.

Second, are the concerns with LADBS. We have satisfied most of the LADBS requirements and are pending an appointment for very few fixes. We have worked with all of LADBS and don't have any issues that aren't easily fixed.

Finally, the concerns of the Homeowners association and Westwood city plan. Most of their concerns are personal problems. If I am not mistaken, they believe UCLA is also a nuisance. Many of the mentioned information is not factual and the individuals have dramatized events to weaken my character as an operator.

We had some minor issues with management but have got it under control now. The owner had a surgery and we had an unexpected increase of

business during the pandemic which we changed our structure to handle now.

We are happy to work with the city and keep compliant. Every business owner in Westwood has to fend for themselves now. So many business owners have written on behalf of us as they are upset with the homeless issue, lack of response time by LAPD, concerns about violence and vacant stores. The business owners of Westwood collectively suffer immensely because LAPD will say your business is the source of crime if you call for help, the HOA and westwood city will consider you a nuisance if you call for help, and if you are striving in Westwood you are penalized arbitrarily and in a capricious manner.

Habibi cafe boosts the local economy, brings new elite markets to Westwood, supports the students and educational foundations, increases the residential and commercial real estate, brings new job growth to the community and brings diversity and culture to Westwood. Some minor operational issues and the crime from the pandemic era shouldn't be grounds to ruin a successful Westwood business.

Below this statement is a list of alarming recent unusual crime activity further proving crime is unusual and can happen anywhere these days. Are these businesses being subject to the restrictions which are being forced on us?

LAPD discusses crime, safety with Westwood Village business representatives

The Westwood Village Improvement Association held a virtual merchant meeting Tuesday with the LAPD to discuss crime and safety.

Local business representatives, stakeholders and WVIA executive director Andrew Thomas attended the meeting.

The Tuesday meeting followed a citywide tactical [alert](#) issued by the police department on Nov. 26 due to multiple smash-and-grab robberies around the city, according to the Los Angeles Times.

LAPD representatives James Allen, Scott Alpert and Jonathan Tom delivered a presentation on crime and safety in Westwood Village.

Robberies and burglaries rose by 2.9% and 3.6%, respectively, over last year in the area, indicating the Village is not currently a major target, they said. However, major retailers such as 7-Eleven, CVS Pharmacy and Trader Joe's may be a target for burglaries, they added.

Store owners should not place expensive items unlocked near the exits and may use video surveillance cameras to deter crime, Tom said. Signs advising shoppers that they are being filmed and televisions broadcasting filming may also improve their effectiveness, he added.

Tom also said higher quality video cameras may be a wise investment, as lower quality cameras may not allow for a suspect or their vehicle's license plate to be captured, especially during the night. Positioning cameras at exits and on streets where individuals may enter, leave or park their car may also be effective, Tom added.

Stores selling expensive items should secure such items during nighttime closing hours, since most smash-and-grab robberies target the front of the store, Tom said.

Tom also advised owners to clarify expectations for employees in the event of a burglary and that employees should surrender material goods for their own safety to minimize risk and harm to workers.

Tom said that the LAPD may consider placing a decoy vehicle in the Village to deter crime and that it has been working with UCPD on additional patrols through the Village.
