DRAFT ORDINANCE ADDING SUBSECTION (g) TO SECTION 7.27.1 OF THE LOS ANGELES ADMINISTRATIVE CODE TO REQUIRE THE IMPLEMENTATION OF THE OWN-A-PIECE OF LOS ANGELES PROGRAM CONCERNING THE SALE OF CITY-OWNED REMNANT SURPLUS PROPERTY TO COMPLY WITH THE CALIFORNIA PUBLIC RESOURCES CODE

Honorable Members:

As requested by the City Council, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance adds Subsection (g) to Section 7.27.1 of the Los Angeles Administrative Code (LAAC) to amend the Own a Piece of Los Angeles (OPLA) Program to comply with Division 23, Chapter 3 of the California Public Resources Code Section 33207(b), which grants to the Santa Monica Mountains Conservancy (SMMC) the first right of refusal on any surplus City-owned remnant property within the Santa Monica Mountains Zone.

The City of Los Angeles (City) is located in a global biodiversity hotspot called the California Floristic Province, which means it includes more than 1,500 endemic plant species. At least 70 percent of the area's original habitat has been lost due to development. Much of the remaining biodiversity within the Los Angeles is located in the Santa Monica Mountains Zone (zone).

Section 33207(b) of the California Public Resources Code provides that SMMC shall have the first right of refusal on any property within the zone presently owned by a public agency and scheduled for disposal as excess lands, except where such lands are designated for acquisition as a park or recreation area by a federal, state, or local agency. The City Council requested this Office to draft an ordinance amending the sections in the LAAC pertaining to the "Own a Piece of Los Angeles" (OPLA) Program concerning the sale of City-owned remnant surplus property to comply with Section 33207(b) of the California Public Resources Code, thereby providing to SMMC the right of first refusal of land within the zone that is subject to the OPLA Program. The draft ordinance further provides that the SMMC's first right of refusal shall be renewed upon two years after the initial refusal or at any time as required by State law, whichever occurs first.

The draft ordinance was sent, pursuant to Council Rule 38, to the Department of General Services with a request that they provide any comments directly to the City Council or its Committees when the matter is considered.
