An ordinance amending Schedule A of Section 4.61 of the Los Angeles Administrative Code to update the salary for the Assistant General Manager, Civil, Human Rights and Equity Department classification, and to reflect class title changes adopted by the Civil Service Commission for non-represented classifications.
