MOTION

The Los Angeles Fire Department (LAFD) is experiencing operating budget shortfalls in various accounts for reasons as indicated below. Council approval is urgently needed to expedite the necessary transfer of funds to balance salary and expense accounts for a total of \$7.04M. These transactions cannot be deferred to the upcoming Year End Financial Status Report (FSR) due to the depletion of salary accounts and fiscal year end purchasing deadlines. There is no additional General Fund impact as these transactions involve internal transfers and funding budgeted for Fire purposes in the Unappropriated Balance.

- Sworn Overtime (\$3.8M) Expenditures have increased significantly in recent months as a result of the deployment of sworn members on emergency recall to fill field vacancies throughout the City until hiring is ramped up. Recalls are activated when the department cannot fill field posts through additional assigned hire or voluntary overtime. There is insufficient funding to meet payroll for the pay period ending April 23, 2022.
- Unused Sick Time (\$1.32M) MOU changes taking effect in January 2021 which
 increased unused sick time compensation have accelerated expenditures in this
 account beyond projections. The account has been depleted as of the pay period
 ending April 9, 2022, and there is no funding to meet payroll for the pay period
 ending April 23, 2022.
- Civilian Overtime (\$0.92M) Overtime remains a necessity to minimize turnaround times on fire life safety inspections, maximize fleet availability and maintain systems support. Civilian vacancies have exacerbated overtime usage which is now forcing system-generated payouts for excess banked overtime. Funding of \$920,000 is needed to meet the most critical year end needs.
- Fleet Parts Account (\$1.0M) Expenditures have increased significantly in recent months due to surging prices and field demands. This funding cannot be deferred to the Year End FSR as approval of that report typically does not occur until after fiscal year end deadlines for purchase transactions. This account will be depleted as of the pay period ending April 23, 2022.
