

Summary: The Hermon Neighborhood Council supports this motion to create an ordinance requiring greater transparency for tenants' utility bills. Currently, many residential and commercial tenants in multi-unit buildings in Los Angeles pay their landlords or third-party billing services for utilities without seeing any documentation as to the basis of the charges. This leaves tenants with no way of validating that they are being billed accurately and fairly. An ordinance modeled after the one enacted by the City of Seattle in 2003—which requires third-party billing companies to provide detailed statements disclosing charges, meter readings, and contact information for disputing charges to tenants in properties with three or more units—would help ensure equitable billing practices. Additionally, we strongly support any measures to ensure that low-income tenants whose utility bills are processed by private companies can take advantage of low-income utility services, as currently this is not always the case. In light of this, the Hermon Neighborhood Council supports Council File 22-0178 and encourages the City to adopt and implement such an ordinance as soon as possible.
