This will allow the City to create a strategic plan to fund, fix/install access ramps and sidewalks throughout the City and leverage State and Federal grants to help fund the program. ngelenos have submitted more than 61,000 requests for sidewalk/access issues via 311 since August 2015, and almost all are still pending fixes. In 2016, the City settled a \$1.4 billion class action lawsuit, commonly known as the “Willits Settlement,” that determined the City’s crumbling sidewalk infrastructure was not compliant with the Americans with Disabilities Act (ADA) and prevented people with disabilities from traveling and accessing opportunities in Los Angeles. This legal action led the City to develop the “Sidewalk Repair Program,” which as of today is the only program for sidewalks in the City. This City Controller’s most recent audit provides an update on the City’s progress in fixing sidewalks that need repair. There are an estimated 9,000 - 11,000 miles of sidewalks in the City of Los Angeles, but no one is really sure. One of the biggest hurdles in the City’s Sidewalk Repair program is that “the City does not know how many sidewalk locations need repair and how much the repairs will cost.”
