HOMELESSNESS AND POVERTY

MOTION PLANNING & LAND USE MANAGEMENT

The Los Angeles homelessness crisis requires the City to be innovative and cut red tape wherever possible. The number of people sleeping on our streets every night far exceeds the beds we are able to offer. **There are churches, synagogues, mosques, temples and other properties owned by non-profits that are eager to be part of the solution, but are barred based on the location of their property.** We need to continue to work to make it as easy as possible for these charitable organizations to build and operate homeless shelters in the City.

On March 28, 2017, the Los Angeles City Council started this process by adopting Ordinance No. 184836 to amend Section 12.03, 12.80, and 12.81 of the Los Angeles Municipal Code (LAMC) to more quickly establish temporary homeless emergency shelters during a declared shelter crisis. In particular, LAMC Sec. 12.80 allows for temporary shelters for the homeless on City owned and leased properties in any zone as a matter of right. LAMC Sec. 12.81 allows for temporary shelters to be established and operated in the R3, RAS3, R4, RAS4, R5, C2, C4, C5, CM, M1, M2, and M3 zones, if the shelter is operated by a religious institution or a non-profit, charitable organization on property the organization owns or leases.

We need to go further. As a matter of practicality, many religious organizations and other charitable entities that could take advantage of this provision own and/or operate properties in R3 and more restrictive zones. Amending the process would serve the City's goal to produce additional, flexible interim housing solutions as part of a multipronged approach to addressing the housing crisis.

I THEREFORE MOVE that City Council instruct Los Angeles City Planning (LACP), with assistance from other relevant Departments, to report back in 45 days with options to amend Sections 12.03, 12.80, and 12.81 of the LAMC to allow "shelters for the homeless" and other forms of interim housing to be established and operated on properties located **outside of R3, RAS3, R4, RAS4, R5, C2, C4, C5, CM, M1, M2, and M3 zones** during a declared shelter crisis.

I FURTHER MOVE that City Council instruct LACP, with assistance from other relevant Departments, to report back in 45 days with options to amend Section 14.00 of the LAMC to streamline the administrative approval of "shelters for the homeless" as a public benefit project. The report shall consider expanding where shelters can operate as a matter of right, allowing for a broader array of innovative interim housing solutions **by reducing or eliminating certain objective zoning requirements, revising existing performance standards to reflect current best practices, and explore additional strategies to facilitate the provision of interim housing.**





Pacific Palisades Community Council (PPCC) has been the most broad-based community organization and voice of Pacific Palisades since 1973.

At its regularly scheduled Board meeting on April 28, 2022, after full public discussion, the PPCC Board passed the following motion unanimously by all members voting:

“Pacific Palisades Community Council (PPCC) agrees that there is and has been for many years a crisis of homelessness in Los Angeles. We support reasonable and effective measures and policies to address the crisis, including the successful measures and policies adopted by the respected Pacific Palisades Task Force on Homelessness: <https://www.pptfh.org>. We believe that City-owned property (but not sensitive sites such as parks, libraries, schools or daycares) should be the first priority for placement of temporary homeless shelters, and that if any property, including property owned by faith-based institutions, is to be utilized for this purpose, this should only occur after an appropriate review, advance notice to and opportunity for comment by the relevant, affected community. We strongly believe that current zoning protections, including State-mandated reviews and studies, should not be relaxed or overridden, or, if for "emergency" reasons relaxation of these protections is contemplated, a specific time frame should be imposed for any temporary shelters, with clear provisions for removal of such shelters after the time frame expires.

“PPCC opposes the motion in CF 22-0158, for the reasons stated in our letter of February 21, 2022: <http://pacpalicc.org/wp-content/uploads/2022/02/PPCC-Letter-CF22-0158.pdf>. However, should the motion move forward in City Council, we support consideration by City officials, including full consideration of any adverse consequences, of the following:

- Consideration of automatically including LAMC 41.18 protections on any location providing a homeless shelter and authorized pursuant to a declared shelter emergency, including full consideration of adverse consequences if such protections are not included;
- Consideration of mandatory CEQA compliance, including full consideration of adverse consequences if CEQA compliance is not required;

- Consideration of consequences, including full consideration of adverse consequences, of “Cutting red tape,” by removing the public’s right to a transparent approval process including right to notification and the opportunity for public comment, including early notification to NCs and recognized CCs;
- Consideration of the differences and effects of allowing shelters in R1 zones as proposed versus the existing ordinances allowing them in R2 & R3 zones, including full consideration of adverse consequences of such differences and effects;
- Consideration of the effects of limiting shelters within a reasonable radius of sensitive sites such as parks, libraries, schools and daycares, including full consideration of adverse consequences if such limits are not imposed.”

Throwing money at the problem is not working. Creating temporary housing without giving the tenants any way of getting back on their feet, is not the answer. In fact, it is adding to the problem. Are you aware how few of LA's homeless are actually from LA? Most of them came from other parts of the country. My mother was always amazed to hear where they came from. Florida, North Carolina, Illinois, Colorado... There is a "homeless grapevine" all over this country. Word spreads among the homeless of which cities are the most hospitable, which cities offer help, where's the best panhandling, and on and on. For the last few years, I promise you, the word has spread that if you can get to Los Angeles, they will give you a free house! Reminiscent of the gold rush when the word spread that all you had to do was get to California and you could pick up gold nuggets the size of your fist. That was a gross exaggeration of the reality, just as getting a free house is not close to reality. A very, very few get housing but hundreds or thousands keep flooding here expecting to be given the keys to a house! While "temporary housing" is a kind idea, it is actually impractical and making the problem so much worse. And now you want to spread these homeless shelters or tiny villages or whatever all over the city. I doubt that any of the council members proposing this motion would want a homeless shelter within five blocks of their home! Besides the trash and the mentally ill and drug addicts and pan handlers, a lot of criminals have taken to "hiding in plain sight" by blending in with the homeless. Is that what you want living near you? Near your kids? Then drop this motion immediately. Look, before you can come up with a solution to the homeless crisis, you have to understand WHY people become homeless. There are veterans who are struggling and end up homeless. The VA should be helping them including turning several of the grassy acres at VA facilities in to safe camping for vets and offer them drug and alcohol counseling and other help.
