

**ORDINANCE NO. \_\_\_\_\_**

An ordinance determining and declaring that weeds, rubbish, refuse and dirt are upon certain streets, sidewalks, parkways and/or are on or in front of certain private properties in the City of Los Angeles, and are a public nuisance, and declaring the intention of the Council of the City of Los Angeles to order the abatement of same.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Pursuant to the provisions of the Government Code of the State of California (Sections 39560 to 39588, inclusive), the City Council of the City of Los Angeles hereby determines and declares:

That weeds, as defined in Sections 39560 and 39561.5 of said Code, and/or rubbish, refuse and dirt are upon the streets, sidewalks, parkways and/or are on or in front of those certain private properties described and listed in the “2022 Ordinance of Intention Parcel Listing” published by posting for ten days in the City of Los Angeles with this ordinance at the following locations: one copy on the bulletin board located at the Main Street lobby to the City Hall; one copy on the bulletin board located at the Main Street lobby to City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records; and

That the weeds, rubbish, refuse, and dirt are a public nuisance, and such weeds are a seasonal and recurrent public nuisance; and

That said City Council hereby declares its intention to abate said public nuisance in accordance with the aforesaid provisions of the Code.

Sec. 2. The City Clerk is hereby directed to mail, postage prepaid, written notice of the proposed abatement of said public nuisance at least five days prior to the time fixed herein for hearing provided:

- (a) to each person to whom such described property is assessed in the last equalized assessment roll available on the date of the adoption of this ordinance at the address shown on said assessment roll, or
- (b) to the person owning such described property if it was not assessed to a person in said assessment roll, at such person’s last known address by registered mail with a request for a return receipt.

Sec. 3. The City Council hereby fixes the 8<sup>th</sup> day of June 2022, at 10:00 a.m. as the time and the Council Chamber in the City Hall in the City of Los Angeles as the place, that the Council shall hear and consider all objections to the proposed removal of weeds and/or rubbish, refuse and dirt, and any and all persons having any objections to

the proposed removal may appear before the Council and show cause why the public nuisance should not be removed in accordance with this ordinance. At the conclusion of the hearing, which may be continued from time to time, the Council shall allow or overrule any of said objections and its decision thereon is final.

Sec. 4 The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in tree public places in the City of Los Angeles; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located a the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
