Thousands of poor and working class tenants across the city will be evicted if the council lifts the emergency tenant protections. Families continue to suffer severe financial hardships due to covid, thousands have lost income earning family members to covid, and thousands more continue to suffer long term disabilities due to past covid infections. The poor, working class people who were most impacted by the pandemic will be the first to suffer the violence of displacement if the emergency tenants protections are lifted. Contrary to the landlord lobby's frantic and inflammatory comments about tenants taking advantage of the protections, leaving behind a suffering landlord class, the conditions on the ground over the past two years paint a different picture. Both small landlords and corporate entities have engaged in widespread tenant harassment and abuse, resulting in thousands of extra legal evictions during the pandemic, where tenants were bullied or lied into leaving their homes, or illegally locked out of their homes. Landlords actively lie to tenants about the covid protections, coming up with random "expiration dates," or simply telling tenants the protections already expired. Literally thousands of tenants all over the city still have no idea there were every any renter protections in place. I personally have spoken to dozens of tenants who suffered catastrophic personal, medical, financial losses during the pandemic, and literally gave up their own food security and health in order to pay rent, under the duress of constant, violent, landlord harassment. Nearly 100% of tenants the union speaks to knew nothing about their rights or the covid protections until they spoke to the tenants union. Thousands of people who should have received rental assistance never even applied, because landlords failed to follow their obligation to post LAHD notices of the covid protections. The pandemic's impact on the housing market has now created another crisis for tenants, as landlords are frantically attempting to sell off hundreds of RSO properties, occupied by tenants paying affordable rents.
