Dear Councilmembers and Staff,

I am writing this to you to ask for you to deny the extension of the lease on the Venice Bridge House. There has been little warning to the public regarding to this request. Furthermore, I was at the meeting at Westminster Elementary School with Mr. Bonin and Mayor Garcetti when they promised the Bridge Home at Sunset and Main St in Venice would only be in place on a temporary basis for a defined period of time. This was the same meeting during which they promised increased security patrols in the area, only to immediately cancel funding for the increased security patrols the week the bridge home opened.

I live directly across the street from the Venice ABH. While I admire their effort, the project has fallen WOEFULLY short of housing the projected and promised number of people it was supposed to move to more permanent or long term housing. I am EXTREMELY troubled by the lack of management from CD11 regarding the many safety issues that have arisen in our neighborhood.

The Venice ABH is an abject failure. For the millions of dollars that have been spent, a mere handful of people have passed through the Venice ABH onto long-term housing. Whereas there were no tents/encampments on Hampton Drive across the street from the Venice ABH site prior to the opening of the Venice ABH, as soon as the Venice ABH opened and to this day, Hampton Dr between Rose and Sunset is an absolute disaster. It is impossible to walk on the sidewalks on that street. With parked cars along both sides of the street, the street is barely wide enough for two cars to pass in opposing directions. When pedestrians are forced to walk in the street, because they are unable to access the sidewalks due to the massive encampments, trash, bicycle and motorcycle chop shops, etc, it creates an extremely dangerous situation for pedestrians, cyclists, and motorists alike.

The Venice ABH is smack dab in the middle of a residential neighborhood. There used to be no homeless people within a few block radius of the Venice ABH site prior to its opening, now there are homeless people everywhere around the Venice ABH site.

Garcetti and Bonin PROMISED this would not happen, even though at the Westminster Elementary School meeting it was pointed out to them that every time a homeless shelter is opened, it is a guarantee homeless encampment will spring up in the immediate vicinity. Everyone knows this to be the case. There are tens if not hundreds of homeless individuals living within 1-2 blocks of the Venice ABH now, whereas prior to its opening there were none. Reports are that the Venice ABH is largely empty, yet there are the tens and hundreds of homeless right on its doorstep.

The Venice ABH is an abject failure and waste of taxpayer dollars. It has made the homeless situation in my neighborhood DRAMATICALLY WORSE, not better. This was all foreseen and predicted and spelled out for Bonin and Garcetti at the Westminster Elementary School meeting. We, the public, the taxpayers and neighbors in Venice, said this is exactly what would happen, and guess what, we were sadly 100% correct.

There is no reason to continue the lease of this very expensive project since it is helping so few people for the money being spent. Please allow the city to build the mixed use building the city is planning for this site -- i went to most of the planning meetings. This will do wonders for the neighborhood. And guess what, I bet when there are no free services for the nearby homeless that are in effect aiding and abetting and coddling the homeless in Venice surrounding the Venice ABH, there will be less impetus for the homeless to set up show in the area. Handing out free food to the homeless who refuse to go into the Venice ABH system allows these people to live in a dangerous situation -- indeed it makes this lifestyle choice easier for them to maintain -- and to make the neighborhood less safe for all residents.

Most of the homeless in the neighborhood of the Venice ABH DO NOT WANT TO BE HOUSED. They turn down the opportunity to advance to housing because they want to maintain their off-the-grid, anarchist lifestyle. Handing these homeless people free food and water and allowing them to break the laws taxpaying, housed residents have to follow, all while getting to live a 5-minute walk from one of the most beautiful stretches of beach in the world, is a recipe for failure if you are trying to get people off the street. The homeless in the area surrounding the Venice ABH are not respectful neighbors and members of the community. There is trash everywhere. There are people shouting and screaming at all hours of the night on a regular basis. There have been numerous major fires in the encampments surrounding the Venice ABH.

The Venice ABH has destroyed our neighborhood, and for the money has done exceedingly little good.

Councilmember Bonin and CD11 have refused to acknowledge the concerns of the public as to safety and sanitation, whilst ignoring the fact that these concerns directly affect the guests of the Venice Bridge House. Councilmember Bonin unabashedly favors the homeless over the taxpaying housed. He is a destroyer of neighborhoods, hires private security for his own office to protect his campaign team, but cancels the same security funding he promised us to patrol the area around the Venice ABH.

The neighborhood has seen a gigantic spike in crime, and Councilmember Bonin has continually refused to sanitize the streets surrounding the ABH Venice that now contain close to 100 encampment tents.

A vote to continue funding for this project is a vote to further destroy my neighborhood and the lives of the hundreds and thousands of good people who reside in the area. A vote to continue funding of the Venice ABH is a vote that harms the homeless by allowing them to run roughshod over the housed members of the community with impunity, allowing them to be successful in their anarchist lifestyle, yet it puts them in danger of disease and violence.

Our neighborhood has been lied to and abandoned -- very few unhoused people have found housing through the Venice ABH, and the Venice ABH is actually making the homeless problem WORSE.

It's time to come up with a better plan, where taxpayer funds used actually contribute to solving the homeless problem, and not to destroying the neighborhoods the homeless housing projects are constructed in. If the Venice ABH was performing anywhere close to even 50% of the projected street-to-housing rate per month and per year, then it would be worthwhile to consider extending its funding. However, the Venice ABH is a total failure. The height of stupidity is doing the same failed thing over and over and over again, expecting to get a different result. When you try something and it fails, do something else, not more of the same. Putting a homeless shelter in the middle of a residential neighborhood 2 blocks from the beach, WHERE PEOPLE COME SPECIFICALLY TO BE HOMELESS, isn't going to solve the problem because THE HOMELESS PEOPLE IN THIS NEIGHBORHOOD BY AND LARGE DO NOT WANT TO BE HOUSED!

The logic was that if you just build the shelter and give the homeless a path to being housed, they will take you up on it. This doctrine has failed miserably in the neighborhood surrounding the Venice ABH because the homeless people surrounding the Venice ABH DO NOT WANT TO BE HOUSED. I reiterate because this is totally lost on Councilmember Bonin -- he refuses to accept this fact. I see young, physically fit, often mentally ill and/or addicted to drugs men and women who could easily be placed into housing but who REFUSE to go into the Venice ABH.

You need a new plan. Please use the site of the Venice ABH for the mixed-use building the city has been planning and bidding out since prior to the Venice ABH proposal by Councilmember Bonin. Then you will ACTUALLY be doing good for my neighborhood.

I, my family, my friends and my neighbors are counting on you to rectify this abject disaster and make right what has gone so terribly wrong for our neighborhood. Reject outright the request to extend funding for the Venice ABH. Allow the site of the Venice ABH to be used by the City for the mixed-use building it was already planning to build.

Greetings Councilmembers,

I write to you to voice my opposition for the motion to renew or extend the lease of the Venice Bridge Home which is located directly across the street from my house. As a Venice resident of nearly 36 years I was skeptically supportive of the Bridge program when Mayor Garcetti & Councilmember Bonin came to promote it several years ago at a meeting at Westminster Elementary school. The plan was presented as a temporary shelter which would end after 3 years. I can tell you all about these broken promises; that the Bridge program would work with ALL residents, that the focus would be to do outreach and house ONLY those in nearby encampments, that a special enforcement and cleaning zone (SECZ) would be created around the Bridge Home, but you should know that none of this was ever done in Venice.

Venice Bridge has 154 beds and has NEVER been anywhere close to capacity, despite reports to the contrary. I know this because residents tell me and I observe the 40-50 people there on a daily basis.

It cost \$8 Million to build and \$3.5 Million annually in service contracts and has reportedly moved less than 50 people into housing in 26+ months. There is no oversight for this program. The service providers self report with no accountability to anyone.

Since Bridge opened in February 2019, I've spoken with dozens of homeless people, asking them if they've been offered services, if they want housing & my neighbors & I have helped to convince many to utilize Bridge Housing shelter. Unfortunately the first hand accounts from Bridge residents have told a story of failure: to enforce the rules against drugs, alcohol, harassment, robbery, assault and violence. And a failure to move people into housing. A lot more people have been kicked out of Bridge for violating rules than have been moved into housing. What I see everyday is constant arguing, fighting and violence both inside & out. I know that a young man died inside the toilets last summer & I was told it was most likely related to drugs. EMT and police are a constant presence both inside and around the facility. Since Bridge opened our neighborhoods have seen increased fights and arguments in the streets, assaults, rape, burglary, vandalism, the streets & sidewalks used as toilets, used needles and trash all day and night everyday.

We have a mental health crisis and drug addiction crisis in our streets and Venice Bridge not only does little to address the problems but has been a beacon increasing the mentally unstable people drawn to the neighborhood since it opened. Housing is not going to fix this problem and it's time our elected officials acknowledge that the plan you have adopted has failed for the vast majority of people living in the streets and dying every day.

Take this land and build affordable housing for seniors and others who actually want housing. Instead of wasting more of our tax \$ on temporary shelter that doesn't work. I have to ask why outgoing Councilman Bonin wants to push through an extension when it's clear that this program is an abject failure at helping the homeless it purports to have been created for. We should let the voters choose the next CD11 representative and they can decide on the merits whether this program should be renewed. I urge you to please deny the request to extend.

I ask that the clerk please post this letter to the council file as soon as possible.

Dear Honorable Councilmembers:

Please deny this motion to renew or extend the lease to the Venice Bridge Home project (ABH) at the Main Street/Sunset Avenue Metro site. This motion was pushed through a back channel, with a waiver of consideration by the Information, Technology, and General Services Committee. In fact, the public was only made aware of this addition to the council meeting this morning, giving constituents less than 24 hours to arrange a trip to city hall to make a public comment.

The Venice A Bridge Home has had dismal results in being a bridge to permanent housing. Instead, ABH has been a path to nowhere for many who have left and moved back on the streets, while others remain there far longer than the intended period. The results of promises broken to our community - including to the unhoused - are well documented. Assaults, drug dealing, overdoses, and dangerous behavior within Venice ABH are facts. Residents, especially older men, have shared their experiences of the "hell" that is living there. "Everyone knows where the cameras are located and bathrooms are notorious for fights, assaults, drug use, and sexual activity. I try to keep my head down and stay out of sight."

ABH it has also failed the surrounding area by abandoning all assurances made to the SECZ. As a neighbor to ABH, I supported the project and hoped it would be a model for nearby communities. Instead, it will forever be held up as a cautionary tale by opponents of any form of shelter, housing or services. That is a tragedy and it could have been avoided if Mr. Bonin, Mr. Garcetti, and Chief Moore had honored commitments made.

The LA City Council, and much of the current local, state and national government, has lost the trust of the people that elected them. The habitual lack of transparency, outright dishonesty, and contempt for constituents, including the unhoused, is reason enough to deny this motion. If this motion is approved - written by a councilmember that will no longer be in office when the lease is set to expire - voters will wonder what back room deals were made and favors exchanged.

Given these concerns, please deny or put on hold this motion until there can be a public process including community participation with our newly elected CD-11 councilmember.

This motion for renewal or extension of the lease to the A Bridge Home project (ABH) at the Metro 6 site must be denied as there has not been adequate public process or discussion and opportunity for community, Neighborhood Council input, including the waiver of consideration by the Information, Technology, and General Services Committee. Furthermore, it appears that no notice to surrounding property seems to have been required or provided.

Commitments made in conjunction with the ABH have not been kept, and as a result, it has failed to meet its objectives and resulted in collateral consequences for the surrounding housed and unhoused community, including chronic, serious safety and health problems for both housed and unhoused.
