If it wasn't in the beginning. if, indeed, you were worried about the spread of covid amongst your constituents, your several extensions have proved you wrong and landlords are absolutely being targeted. As soon as vaccinations were available and the navigation of living with covid were everywhere, PSA's, news, no lack of information.
