Comments for Public Posting: Allowing homeless encampments at/blocking public institutions, including libraries and schools is a health and safety issue, not just for the general public but specifically for our children, who utilize these institutions. Not just the 'appearance' of homelessness and encampments, but the reality of trash, human urine, feces, drugs, needles, which the homeless often bring, is a true public health and safety concern. I work in a health care setting and deal with the unhoused population on a daily basis...we provide food, clothing - as needed, referrals to homeless drop in centers, casemgmt services, and even referrals to Recuperative care, where our hospital pays for them to go and be housed for a few weeks. I schedule mental health apptmts, provide referrals for alcohol/drug resources, as well as education and referrals re: how to apply for Cal-Fresh programs; however, unless a client is interested in these referrals, or willing to move into shelters or other designated housing referrals or get connected to casemgmt services vs setting up encampments wherever they want is an ongoing debate. But allowing the unhoused to set up encampments next to a school or library where young children are at, is incredibly reckless and dangerous, unless of course, the library or school is being shut down, and no further children's participation is wanted. Safe parking areas, under bridges or even under FWY underpasses is at least away from places where children are required to be.

Despite what council believes, a significant portion of Angelenos oppose criminalization as a tool to address homelessness, knowing that it is expensive, ineffective, and inhumane. For previous amendments, every address of a 41.18 zone was listed, reviewed and voted upon, and transparent to the public. At this point it's unclear how many neighborhoods and people will be impacted by this, but there are thousands of sites within LA City boundaries. Most unhoused people do want some type of housing option but too many of the options offer are bait and switch or are cruelly carceral. People are forced to give up the few possessions they have, can't keep their pets, or have communication with their friends. They have curfews and bag searches. The unhoused are treated like criminals many of the places Project Roomkey offered. Punished severely for unfair rules and unduly controlled. Is it no wonder that staying on the street and being able to keep some personal freedom feels like a better option despite the risks. Clearing encampments only serves to further traumatize these members of our community. Too often personal belongings, important paperwork, and life saving medicines are thrown away without a second thought. Only making it that much harder for people to find stability. Oppose – Prohibiting sitting, lying, sleeping and storage of personal property in the public right of way near schools and daycare centers - Council File 20-1376-S1

Dear Councilmembers,

We write on behalf of Abundant Housing LA **in opposition** to the motion dated July 1st, 2022, in [Council File 20-1376-S1](#), which directs the City Council to adopt an ordinance amending Section 41.18 of the Los Angeles Municipal Code (LAMC) to make it unlawful for a person to sit, lie, or sleep, or to store, use, maintain, or place personal property within 500 feet of schools and daycare centers, and beyond to the end of any block if a portion of a block falls within the radius of “sensitive areas”.

Abundant Housing LA is a pro-housing, nonprofit advocacy organization working to help solve Southern California’s housing crisis. We support reforms to legalize more homes, make homes easier to build, increase funding for affordable housing, and protect tenants, which are all needed to make housing more affordable, improve access to jobs and transit, promote greater environmental sustainability, and advance racial and economic equity. As a community organization, in order to maintain our independence, we do not accept financial support from housing developers or their consultants.

AHLA opposes approaches that superficially attempt to remove unhoused people, instead of tackling the systemic root causes of the housing and homelessness crisis. Not only is it ineffective, but it unjustly punishes people who are facing the consequences of inaction and exclusionary housing planning.

In particular, the proposed amendments to LAMC Section 41.18 would prohibit a person from sitting, lying, sleeping, and storing, using, maintaining, or placing personal property within a 500 feet radius of schools and daycare centers. In a [2020 report](#), researchers from UCLA found that there are over 269,000 homeless K-12 students in California, with 18,979 enrolled in LAUSD schools and 4,000 enrolled in LA County charter schools. For most of these students, schools are an irreplaceable source of essential resources such as water, hygiene facilities, and the internet. Broadly banning homelessness near schools is akin to cutting homeless students off of this critical lifeline. Furthermore, this policy stigmatizes people experiencing homelessness, and particularly homeless youth, treating them in effect as a threat, when in reality their own

marginalization makes them more likely to be victims of violence. When the City of Los Angeles spends more effort sweeping homelessness out of sight than building affordable housing, it sends a clear message of disrespect and indifference to the precious human beings who have no recourse but to try and survive on our streets.

The motion will also significantly expand 41.18 enforcement zone to include the entire city block if any portion of the block falls within the 500 foot radius of designated “sensitive areas”. This will push homelessness further into concentrated and isolated areas far from resources, resulting in the completely unnecessary suffering of homeless individuals and imposing even greater barriers to outreach, while breaking hard-earned trust between homeless individuals and outreach/service providers.

The motion intensifies the removal of unhoused people in public areas, when there are no viable alternative places for these individuals to go. The need for additional shelter beds, interim housing and permanent supportive housing in the City of Los Angeles is a serious and well-documented problem. The Los Angeles Homeless Services Authority’s November 2021 [Homelessness Statistics by City report](#) provides clarity in this regard. In the January 2020 homeless count, which predates the widespread impact of COVID-19 in California, there were 41,290 unsheltered people counted in the City of Los Angeles. In the most recent quarter assessed by the report, only 1,331 people were placed into permanent housing, only 3,475 people were placed into interim housing, and only 1,263 people received rapid re-housing assistance. Housing placements are not keeping up with the identified need, let alone with the needs of those people who do not show up in the count because of the difficulty inherent in counting people who may seek to stay out of view due to issues such as public and police harassment.

Homelessness disproportionately impacts Black and Latino Angelenos. Therefore, the removal of unhoused people without tackling the systemic root causes of the housing and homelessness crisis exacerbates racial inequity and the racial divide in educational attainment and economic mobility. 70% of homeless students are Latinos; Black people are 8% of L.A.’s population, but represent 34% of people experiencing homelessness, according to the 2020 homeless count.

Homelessness will not be effectively reduced without addressing the larger housing affordability crisis, which is driven by a housing shortage. For example, between 2014 and 2019 median rent in Los Angeles increased by 28.0% per American Community Survey data, while the Los Angeles Area consumer price index between those years rose only 12.3%. When housing prices rise faster than inflation, people of modest means are forced to live in overcrowded conditions, forgo other necessary expenses and in the most extreme cases, are pushed into homelessness. In fact, the U.S. Government Accountability Office found that a \$100 increase in median rent is associated with a 9% increase in homelessness.

Instead of spending time, energy, and public dollars on unproductive criminalization, we urge you to build permanent supportive homes to house formerly homeless Angelenos, and allow

more housing to be built in general so as not to exacerbate homelessness faster than we are ameliorating it. For these reasons, we strongly oppose the motion and the proposed ordinance, and we request a meeting to discuss constructive policy solutions to homelessness.

Comments for Public Posting: I am beyond horrified by City Council's plan to massively expand the zones from which unhoused people are banished. This plan is not about solving homelessness or about public safety: it is about disappearing unhoused neighbors because rich and housed Angelenos are uncomfortable facing the reality of our homelessness crisis. The solution to homelessness is housing. Banishment makes it HARDER for caseworkers to reach people and connect them to housing. It destroys stability. Furthermore, criminalization through measures like this provide unnecessary, dangerous contact between unhoused people and police and leave many with criminal records that impede restarting their lives. This policy is cruel. It will do no good but only harm. Council has not even fully considered its effects, which is why volunteers had to provide a map of affected locations. This proposed amendment is the most dramatic expansion of 41.18, creating unhoused exclusion zones across a massive portion of Los Angeles. Despite what council believes, a significant portion of Angelenos oppose criminalization as a tool to address homelessness, knowing that it is expensive, ineffective, and inhumane. For previous amendments, every address of a 41.18 zone was listed, reviewed and voted upon, and transparent to the public. At this point it's unclear how many neighborhoods and people will be impacted by this, but there are thousands of sites within LA City boundaries. Mapping and analysis by volunteers estimates at least 2,100 NEW criminalization zones, totalling at least 46 sq. miles. The actual impact of the law is unknown because City Council has not done the work of determining the specific locations. The proposed mandatory enforcement within 500 feet of schools and daycare centers will have an even greater negative impact on youth and adults experiencing homelessness. Students and children are greatly impacted by homelessness and housing instability. Schools are an important community resource for supporting unhoused students and young Angelenos at risk of homelessness. This blanket expansion does not take into consideration how this could affect this population. Since the passage of 41.18 one year ago, unhoused deaths have increased by 22% (source). 41.18 = death. The 41.18 policy is violence against unhoused people. As a Christian, an advocate for unhoused people, a homeowner, and a parent who is concerned about making our city safe for ALL, I

One of the worst examples is the situation at Westminster elementary school in Venice. There was an RV camped outside the school for over a year and many tents. Needles were picked up on a daily basis. LAUSD paid to put a privacy detail on the school fence which cost over \$100,000 according to school personnel. If there was enforcement of No camping that money could have been used to fund another teacher instead of a costly privacy detail. At Broadway elementary in Venice, there have been many incidents that the unhoused have harassed parents and the children are scared to cross Lincoln to go to school. At Westside Neighborhood School in Playa Vista, there is an RV encampment where an unhoused overdosed on the sidewalk and was discovered at morning entry time as the children are entering school. At this point it's unclear how many neighborhoods and people will be impacted by this, but there are thousands of sites within LA City boundaries. -Mapping and analysis by volunteers estimates at least 2,100 NEW criminalization zones, totaling at least 46 sq. miles. The actual impact of the law is unknown because City Council has not done the work of determining the specific locations. -The proposed mandatory enforcement within 500 feet of schools and daycare centers will have an even greater negative impact on youth and adults experiencing homelessness. Students and children are greatly impacted by homelessness and housing instability. Schools are an important community resource for supporting unhoused students and young Angelenos at risk of homelessness.
