You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing **telephonically** on **Tuesday, August 16, 2022** at approximately **2:00 PM**, or soon thereafter, to consider the following: Categorical Exemption from the California Environmental Quality Act (CEQA) pursuant to Section 15332, Article 19 (Class 32) of the CEQA Guidelines, and related CEQA findings; report from the Department of City Planning, and an Appeal filed by Enrique Velasquez, Coalition for an Equitable Westlake Macarthur Park, from the determination of the Director of Planning, in approving a Categorical Exemption as the environmental clearance for a proposed Tier 3 Transit Oriented Communities Affordable Housing project involving the construction, use, and maintenance of a new, 77-unit, 92-foot, four-inch in height residential building, setting aside eight of the 77 units for Extremely Low-Income Households, comprised of 33 studios, 31 one-bedroom units, and 13 two-bedroom units, and proposing to provide 39 automobile parking spaces, as well as 60 long-term bicycle spaces and 5 short-term bicycle spaces for the property located at 950-962 ½ South Berendo Street.
