

**ORDINANCE NO. \_\_\_\_\_**

An ordinance approving the opening, establishment, and maintenance of a public bikeway and pedestrian path in and through park land located in Reseda Park, under the control and jurisdiction of the Board of Recreation and Park Commissioners.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. The Council of the City of Los Angeles hereby finds and determines that the public interest and necessity require the opening, establishment, and maintenance of a public bikeway and pedestrian path in and through park land located in Reseda Park, as further described in Section 2, below.

Sec. 2. On June 16, 2022, the Board of Recreation and Park Commissioners approved the granting of a perpetual, non-exclusive right to the Board of Public Works to construct, operate, and maintain a public bikeway and pedestrian path within an area of land in Reseda Park more particularly described on Exhibit A and Exhibit B, with the Assessor Parcel Numbers of: 2124-001-902 and 2124-001-903. In so approving, the Board of Recreation and Park Commissioners adopted Resolution Number 10610 authorizing, and requesting that the City Council approve by ordinance, this grant of right. In accordance with the requirements of the City Charter, the Council of the City of Los Angeles further approves the granting of a perpetual, non-exclusive right to the Board of Public Works to construct, operate, and maintain a public bikeway and pedestrian path within an area of land in Reseda Park more particularly described on Exhibit A and Exhibit B, with the Assessor Parcel Numbers of: 2124-001-902 and 2124-001-903. Exhibit A and Exhibit B are attached hereto and incorporated herein.

Sec. 3. The Department of Recreation and Parks, with the assistance of the City Attorney, is authorized to draft the necessary documents to accomplish this grant of right. The President and Secretary of the Board of Recreation and Park Commissioners of the City of Los Angeles are authorized to execute the grant of right and related conveyance documents and the City Clerk is authorized to attest thereto and to affix the City Seal, all subject to the approval of the City Attorney, to affect this ordinance.

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
