Faith for SAFER Streets is a faith-based coalition brought about to work towards reducing traffic-caused fatalities to Zero, focusing on the hardest-hit areas of South Los Angeles. The leadership for Faith for SAFER Streets represents networks of over 800 houses of worship in South Los Angeles, Southern California, and across the State of California.

We are asking the City Council to please vote YES on this contract and help develop Los Angeles bus shelters as the backbone of our city's zero-emissions mobility future.

For too many Angelenos, bus shelters have been woefully inadequate. In much of South Los Angeles, bus benches and covered bus shelters are simply non-existent. Over the past 20 years, there have been only 660 new bus shelters installed for daily transit riders. Most bus shelters lack basic amenities, such as shade, seating, or real-time route information. The absence of these amenities discourages mass-transit ridership, taking precious resources away from our transit system; makes engaging in human-powered transit more onerous; and incentivizes individual motor-vehicle transportation, creating more crowded and dangerous streets for all road users.

- 100% of bus stops will have real-time departures and city information.

As the City of Los Angeles moves towards expanding sustainable transit, we must continue to invest in resources that ensure that public transit receives equitable improvements necessary to not only reduce congestion, but also ensure the City meets its climate change goals. With our bus stops serving as transportation hubs, LACBC believes that the multimodal approach will draw more Angelenos to feel comfortable making the choice of transit over private automobiles.

We strongly encourage approval of this contract so Los Angeles can start building the multi-modal transportation system Angelenos deserve.
