

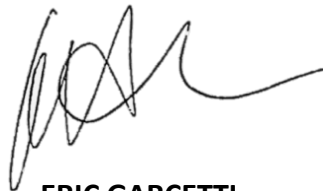

**DISCUSSION**

This monetary donation for \$62,415.00 will be used to purchase the TSOP. The donor, Air Support Angels Foundation, made one donation to the Department in 2021 valued at \$15,400.00; two donations in 2020 valued at \$16,908.00; and two donations in 2019 valued at \$17,021.40. The donor has been vetted by the Air Support Division. The donor is a private organization who has offered their assistance to the Air Support Division. The donor has not entered into, performed under, or sought after a contract with the Department; they have not attempted to influence the Department in the past year in a way that would have a direct effect on any individual or Booster Association. The donor may have licenses, permits or other entitlements for use that the Department has influence over; however, there are no open investigations or other potential factors that may give the appearance of conflict of interest in accepting this donation. No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement or recommendation and the donor is not allowed the use of any Department patents.

Administrative Services Bureau has reviewed the donation and ensured the command has verified that there are no personal relations or conflicts associated with the involved vendors. **SUBJECT:** ACCEPTANCE OF DONATION

It is requested that Administrative Services Bureau approve and forward this correspondence to the Board of Police Commissioners to accept the unsolicited monetary donation of \$62,415.00 to pay for Tyler Special Operations Platform (TSOP). The TSOP is tactical helicopter equipment designed for improved mission safety and effectiveness. The new and light weight benches consist of two externally mounted platforms. An aircraft's weight has a direct effect on its overall stability and performance, the lighter mission equipment, the safer the flight. Installation is user-friendly and requires no modification to the airframe. The TSOP mounts to the helicopter's skids, forward and aft, with unique clamp brackets and anchor points for a safety harness. This donation will not be accepted nor placed in use until the Department receives approval from the Board of Police Commissioners, as per the Los Angeles Police Department Manual, Volume III, Section 350.20.


