**Subject: Release of Remaining A Bridge Home Funds**

Honorable Members:

During the City Council's consideration of the Mayor's proposed budget for the Fiscal Year (FY) 2022/2023, Council File No. 22-0600, the City Council requested the Los Angeles Police Department (Department) to provide a report to the Public Safety and Budget and Finance Committees, regarding the use of the overtime funds allocated for A Bridge Home (ABH) and other homeless housing sites.

As requested by the City Council, the Department presents the following:

- A plan to utilize the total allocated eight million dollars in ABH funds;
- A system to track ABH fund expenditures;
- A plan to utilize the one million dollars for shelter interventions beyond the ABH funds; and,
- A system to track the shelter intervention expenditures beyond the ABH funds.

As such, the Department is respectfully requesting the transfer of the following from the Unappropriated Balance, Police Department ABH Account to the Department's Overtime Sworn Account (Fund 100, Department 70, Account Number 001092, Sworn Overtime):

- The remaining four million dollars of the total eight million dollars in ABH funds allocated for FY 2022/2023; and,
- The one million dollars in funds for shelter interventions beyond the ABH funds allocated for FY 2022/2023.

**DISCUSSION****Allocation of ABH funds across all Council Districts for the FY 2022/2023:**

The Department recognizes all 27 ABH sites designated by the Office of the Mayor (see Table No. 1):

From the FY 2022/2023 ABH funds, each Council District will be allocated a base amount of 3,996 hours (see Table No. 2; Base Allotted Hours). An additional 1,000 hours per site will be allocated to each Council District based on the ABH site locations (see Table No. 2; ABH Allotted Hours).

**Utilization of ABH Funds:**

The Department has provided guidance on the utilization of the ABH funds to the geographic bureau and Area commands. The ABH funds are to be used on an overtime basis to support patrol and special enforcement operations, such as crime suppression and quality of life issues with a nexus to homelessness and persons experiencing homelessness. Criteria for use of the ABH funds are as follows:

1. The funds may be utilized for Comprehensive Cleaning and Rapid Engagement (CARE / CARE+) operations; the enforcement of Los Angeles Municipal Code (LAMC) sections 41.18 and 56.11; and/or to deter repopulation in prohibited areas pursuant to the aforementioned LAMC sections.
2. The funds may be utilized for homeless related vehicle impound operations and oversized vehicle impounds.
3. In support of operations conducted by the Department of Recreation and Parks, the Department of Transportation, and the Department of Sanitation in response to requests from City Council Districts.
4. Deployment of resources is not limited to ABH Special Enforcement and Cleaning Zones (SECZ) but is open to any crime suppression in the geographic Area where persons experiencing homelessness are a factor.
5. Primary consideration will be the utilization of specialized units including, but not limited to, Narcotics Enforcement Details, Vice Units, Gang Enforcement Details, Bike Details, Senior Lead Officers, Task Forces, and Footbeats. Secondary consideration will be for high visibility uniformed presence within ABH SECZ areas based on data-driven research.
6. Each bureau's deployment plan will consider crime classifications involving persons experiencing homelessness as suspects, victims, and/or witnesses as well as homeless encampments as areas of occurrences.
7. Detectives will conduct Wanted Persons Task Forces on weekends to locate and arrest persons experiencing homelessness identified as perpetrators of violent crimes.

The criteria outlined above are the basic considerations for the use of the ABH funds. However, based on data gathered and the progression of the ABH funds usage, the criteria may be modified to better serve the needs of each City Council District.

**Utilization of funds for shelter interventions beyond ABH:**

The one million dollars in funds will be equally distributed amongst all 15 Council Districts. Each Council District will receive 724 hours. Expenditure of these funds will be utilized for shelter interventions not covered by the ABH fund allocation (see Table No. 3).

**Tracking of Funds:**

The expenditure of funds will be tracked on the Department’s On-Line Overtime System (OLOTS). Area commands were instructed to utilize a specific code and corresponding narrative to identify the use of funds in OLOTS. Funds tracked on OLOTS will be monitored by the Homeless Coordinator’s Office within the Office of Operations.

Additionally, Area commands are required to submit expenditures to their respective bureau commands every two weeks. The information gathered by the bureau commands is forwarded to the Office of Operations on the Thursday following the end of the pay period. The Office of Operations will compile the expenditures in a database, separate from OLOTS, to act as a fail-safe mechanism for tracking purposes.

The ABH funds as well as the shelter intervention funds beyond ABH will be tracked on separate but identical databases. All databases will be updated and maintained by the Homeless Coordinator’s Office within the Office of Operations.

**Tracking of Operational Results:**

Along with the continuous submissions of the bi-weekly expenditures, the Area commands are required to submit a results-based tracking matrix which encompasses the productivity of the operations. The matrix is designed for the Department to gauge the effectiveness of operations

in which the ABH funds and the funds for shelter interventions beyond ABH are utilized. These matrices will be updated and maintained by the Homeless Coordinator’s Office, Office of Operations (see Table No. 4).
