Can you please provide the tentative PLUM Committee hearing date for the project?

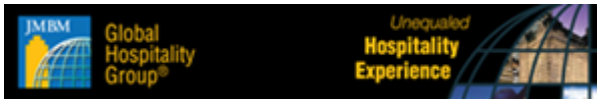
