DOWNTOWN COMMUNITY PLAN UPDATE and NEW ZONING CODE; CPC-2017-432-CPU, CPC-2014-1582-CA

Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the September 23, 2021 actions of the City Planning Commission approving the proposed General Plan amendments to the Downtown Community Plan, Framework Element and Mobility Element.

The proposed General Plan amendments to the Downtown Community Plan, and related amendments to the Framework Element and Mobility Element, are submitted to you for your recommendation, which is to be forwarded to the City Council as specified by Section 11.5.6 of the Los Angeles Municipal Code.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed amendments to the Central City and Central City North Community Plans, (jointly referred to as the "Downtown Community Plan"), Community Plan Boundary Map, General Plan Framework Element, Mobility Element, Proposed Zoning Code and Zoning Code Maps, including adoption of the New Zoning Code Ordinance, Downtown Community Plan Implementation Overlay (CPIO), Community Benefits Trust Fund Ordinance, Community Benefits Fee Ordinance, River Improvement Overlay (RIO) amendments, Greater Downtown Housing Incentive Ordinance amendments, Downtown Affordable Housing Trust Fund establishing Ordinance, Pipeline Parking Alignment Ordinance, Community Plan Consolidation Ordinance, and Rescission of the Downtown Design Guide and Bunker Hill Specific Plan Ordinance, will be consistent with the City's General Plan.

Your action is requested on the proposed General Plan amendments as specified by Section 11.5.6 of the Los Angeles Municipal Code. The zone changes will be transmitted to you following the City Council's action.

RECOMMENDATION

That the Mayor:

- 1. <u>Concur</u> in the attached action of the City Planning Commission relative to its approval of the proposed General Plan amendments for the Downtown Community Plan; and
- 2. Recommend that the City Council adopt the attached Findings of the City Planning Commission relative to the General Plan amendments; and
- 3. Recommend that the City Council adopt, by Resolution, the General Plan amendments to the Central City and Central City North Community Plans (jointly referred to as the "Downtown Community Plan"), the Plan Boundary Change Map to consolidate the Central City Community Plan area and Central City North Community Plan area into the new Downtown Community Plan Area, Citywide General Plan Framework Element, and Mobility Element, as shown in the attached Exhibit C, Exhibit C.5, Exhibit C.6, and Exhibit C.7.
- 4. Recommend that the City Council direct staff to revise the following, in accordance with this action:
 - 1. The Downtown Community Plan as shown in Exhibit C.1; the General Plan Land Use Map for the Downtown Community Plan, inclusive of Symbols, Footnotes, and Corresponding Zone and Land Use Nomenclature as shown in Exhibit C.3, and the General Plan Land Use Change Maps and Matrices as shown in Exhibit C.4.
 - 2. The Plan Boundary Change Map to consolidate the Central City Community Plan area and Central City North Community Plan area into the new Downtown Plan Area as shown in Exhibit C.5.
 - 3. The Mobility Plan 2035 to reclassify selected streets and enhanced networks, as shown in Exhibit C.7.
 - 4. The Citywide General Plan Framework Element, as shown in Exhibit C.6.
