# REQUEST FOR CLOSED SESSION PURSUANT TO GOVERNMENT CODE SECTION 54956.9(d)(1)

Honorable Members:
Pursuant to California Government Code Section 545956.9(d)(1), the City Attorney's Office wishes to meet in closed session to discuss the need for additional funding for the following outside counsel contracts and puts forth the following Recommendations for the City Council's consideration:
A. Recommendation related to cases funded by UB line item:

1. Transfer $\$ 1,495,000$ from the Unappropriated Balance, Outside Counsel Including Workers Compensation line item to the City Attorney, Fund 100, Department No. 12, Account No. 009301;
2. Transfer $\$ 5,000$ from the Unappropriated Balance, Outside Counsel Including Workers Compensation line item to the City Attorney, Fund 100, Department No. 12, Account No. 009302;
3. Acknowledge the remaining amount of $\$ 24,980$ from a settlement involving several wireless telephone companies and authorize the use of this balance for existing outside counsel matters;
4. Authorize the City Attorney to amend the following contracts to increase their respective authority amounts as follows:

5. Authorize the City Attorney to enter into a contract with the law firm Tharpe \& Howell, LLP for assistance with the litigation Eric C. Ingstad, et al. v. City of Los Angeles, 2:22-CV-04772 in an initial amount of \$370,000.

## B. Recommendations related to cases funded from other sources:

6. Direct the CAO to immediately identify a source of funds in the amount of $\$ 1,375,000$, for the police protest cases, currently being handled by outside counsel, and authorize the Controller to process the transfer of the identified funds to Fund 100, Department 12, Account 009301 based on the CAO's recommendation. This funding should come from outside the City Attorney's Office.
7. Authorize the City Attorney to amend the following contracts related to police protest cases to increase their respective authority amounts as follows:

8. Transfer $\$ 500,000$ from City Attorney, Fund 100, Department No. 12, Account No. 001010 Salary General to Fund 100, Department 12, Account 009301 to allocate to the following law firms in these respective amounts for assistance with overflow in the police litigation
unit, and authorize the City Attorney to enter into contracts with those law firms:

9. Acknowledge receipt of $\$ 40,000$ from the United States Treasury (CR23120001635 - Fund 100, Dept. 12, Revenue Source 5188) and appropriate same to Fund 100, Department 12, Account No. 009301 and authorize the City Attorney to amend its contract with Kaplan Kirsch \& Rockwell to increase its authority by that amount;
10. Authorize the City Attorney to amend Contract $\mathrm{C}-135530$ with Nossaman to extend its term to June 30, 2025;
11. Authorize the City Attorney or designee to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the CAO, and authorize the Controller to implement the instructions.
