Comments for Public Posting: I strongly support implementing Sunset4All as soon as possible. I live in Silverlake on Venango Circle and commute daily by electric bicycle into DTLA. I frequently have close calls with motorists that, if it weren't due to my own quick movement, would have left me maimed or dead. This is 100% due to the street configuration in demanding automobiles and micromobility share common space with zero guidance beyond white paint. On September 8th, I had yet another close call where an oblivious motorist merged through the bike lane trying to "score" parking while I was in the bike lane. I had my helmet on, reflective vest, and even a bike-mounted car horn, and these things did not prevent me nearly getting crushed. After we both stopped, I asked him if he even saw me and he said no while continuing to stare at his phone. Previous incidents include a BMW driver threatening to fight me for honking at him parking in the bike lane at the Maison Kitsuné store, Elio's Pizza Truck occupying the westbound bike lane daily at Sunset & Rampart with zero enforcement causing me to swerve into traffic, and gang members following me for blocks and threatening me because I dared take the lane (as I am legally obligated to!) in front of their vehicle to avoid an obstruction. It's very clear the current system of paint markings keeping bikers between parked cars and moving cars is not sufficient protection. Physically separating motorists and micromobility is a simple way to prevent further deaths and injury, as well as a way to encourage additional micromobility users. Every additional trip by bike, ebike, and scooter is one less car trip, which reduces strain on the environment, and also lessens traffic for those who must drive. As an infrequent driver myself, I find it frustrating when the road configuration forces me into potentially unsafe interactions with bicyclists. It's the unfortunate reality of physics that the cyclist bares the full weight of any risk taken, regardless of who is at fault. We MUST separate the road users wherever possible. Lastly, Sunset would just be an overall nicer street if we had more micromobility lanes. Imagine eating at Low Boy's sidewalk seating without someone trying to open a car door into your table. Imagine getting to Dodger's Stadium on an ebike and parking it right at the gate, skipping the terrible parking situation both heading in and out of the stadium. Imagine heading to an evening out at Los Globos from your apartment near Echo

Park Lake without needing to call an Uber because the distance is just barely too far to walk, but perfect for a scooter. Imagine heading home from that evening out without having that illegally modified loud Dodge Charger screaming down the road nearly hitting you as you're just trying to avoid getting doored from the current Sunset configuration. With a separated micromobility lane, we can have this utopia. Please implement Sunset4All as quickly as possible. We cannot wait any longer.

Comments for Public Posting: For too long the city has only considered the safety, time, and desires of drivers. Drivers are given every option to travel about the city and park as they please. Pedestrians and cyclists beg for scraps, and are rarely given little more than a massive compromise that ultimately services drivers (even our city's so-called 'protected' bike lanes offer zero actual protection if a driver were to drive into the bollards, crumpling instantly at contact with any vehicle, as drivers' paint jobs are apparently more important than cyclists' lives). The Sunset4All plan is a bare minimum that is absolutely necessary for non-drivers to travel the east side of Los Angeles, and it is ludicrous to even be having these kinds of discussions. Sunset is already a major thoroughfare for cyclists because there are no other options; but as an experienced rider myself (living a car-free lifestyle and commuting that route regularly for business and pleasure), Sunset has never felt like anything but a death trap. Every time I ride the street I think "is today the day I die" with a seriousness that is incredibly mentally draining. I've been hit numerous times, and had too many potentially deadly close-calls to count. I ride cautiously with a ton of lights, bright clothes, the best helmet, a GoPro always filming, every safety precaution possible, and yet I stand almost no chance or survival in many situations on Sunset. With the brutal effects of climate change already showing up at our doors, it is long past time to get more people out of their cars and into more efficient and community-forward modes of transportation. Protected bike lanes would be a massive boon to local businesses, making it SO much easier for people to get from Silverlake to Echo Park and even to downtown, Chinatown, & Los Feliz. The more people don't need to circle the block miserably looking for parking, the longer they'll stay and visit businesses. Please understand that Sunset4All is already a massive compromise. Pedestrians and cyclists are asking for the bare minimum. We just want to get where we're going alive. That shouldn't be too much to ask.

Sunset & Santa Monica Boulevards through East Hollywood, Silver Lake, and Echo Park were once part of the historic Route 66. Other communities such as Old Town Pasadena, West Hollywood, and Santa Monica have transformed their segments of Route 66 into true “main streets” for their communities by installing improvements such as safer crosswalks, protected bike lanes, shade, beautification, and better transit infrastructure.
