There were no obvious signs of trauma on Ms. Johnson's body and her cause of death was listed as undetermined. The suspect remains unidentified. Detectives are continuing to investigate this crime, but have not been able to identify any suspect, or suspects. Detectives believe a reward may compel members of the public to provide information on the person or persons responsible for this crime.
