### RECOMMENDATIONS

That the Council, subject to the approval of the Mayor:

1. Authorize the Fire Chief, or designee, to deposit the Federal Emergency Management Agency (FEMA) Urban Search and Rescue (US&R) grant funds received under this Cooperative Agreement into Fund 335, Department 38, Account 38020R;
2. Authorize the Controller, to transfer 2020 FEMA US&R grant funds from Fund 335, Account 38020R, to various Fund 100, Department 38 salary accounts as follows: 001012, Salaries Sworn Account; 001010, Salaries General Account; 001090, Overtime General Account; and 001098, Variable Staffing Account, upon submission of proper documentation by the Los Angeles Fire Department (LAFD), for direct staff costs incurred during the grant performance period;
3. Authorize the Controller to transfer 2020 FEMA US&R grant funds from Fund 335, Account 38020R to Fund 100, Department 38, Revenue Source 5346, Reimbursement of Grant Related Costs, for fringe benefits upon submission of proper documentation by the LAFD during the grant performance period; and,
4. Authorize the LAFD to prepare Controller instructions for any technical adjustments, subject to the approval of the Office of the City Administrative Officer (CAO), and authorize the Controller to implement the instructions.

## **SUMMARY**

In accordance with Executive Directive No. 3, the Los Angeles Fire Department (LAFD) requests to continue \$643,565 in grant funding relative to the 2020 Federal Emergency Management Agency (FEMA) Urban Search and Rescue (US&R) grant award. The grant performance period for the 2020 FEMA US&R grant award is a three-year term beginning September 1, 2020 through August 31, 2023. There is no match requirement for this grant.

## **BACKGROUND**

On April 4, 1993, the City entered into a Memorandum of Agreement (MOA) with FEMA and the Governor's Office of Emergency Services, to establish the LAFD as one of 28 participating agencies of the FEMA US&R Task Force (C.F. 92-2021-S1). Under the terms of the MOA, the LAFD is responsible for California Task Force 1 (CA-TF1) recruitment and training, designating a Program Manager, maintaining capability for 24-hour activation, and complying with financial, administrative, reimbursement, and reporting requirements. As a sponsoring agency of the US&R Task Force, the LAFD receives annual grant support from FEMA to support, maintain, and enhance CA-TF1. Upon request by the State or Federal government, the LAFD will mobilize US&R CA-TF1 for the purpose of locating, extricating, and providing initial medical treatment to trapped victims of structural collapses at a designated disaster site.

### **Grant Award Continuation for FY 2022-23**

On April 21, 2021, the Council approved and accepted the terms of a grant award totaling \$1,180,631 in support of the City's US&R Task Force with a grant performance period beginning September 1, 2020 through August 31, 2023 (C.F. 20-1387). Funds were programmed to cover personnel costs (\$536,624), specialized training costs (\$130,650), administrative and operational expenses (\$471,107), and equipment maintenance (\$42,250).

On January 11, 2022, the Council approved the Public Safety Committee report for the acceptance of supplemental funding in the amount of \$47,918 increasing the grant award to \$1,228,549. The grant performance period remained unchanged. On November 16, 2021, the Board of Fire Commissioners (Board) approved a LAFD report requesting to continue \$866,627 in funding from the 2020 FEMA US&R grant award.

At its meeting on September 20, 2022, the Board of Fire Commissioners approved a LAFD report requesting to continue \$643,565 in funding from the 2020 FEMA US&R grant award appropriated for salaries, personnel training, contractual services, travel, supplies and the purchase of equipment for program operations.

In accordance with Los Angeles Administrative Code (LAAC) Section 14.6, the LAFD is required to transmit grant applications for Mayor and Council approval before accepting and receiving the grant award. In addition, Mayoral approval is required for any grant program amendments, subject to the approval of the City Attorney as to form (LAAC 14.8).

## **FISCAL IMPACT STATEMENT**

Approval of the recommendations stated in this report will authorize the Los Angeles Fire Department (LAFD) to continue \$643,565 in funding that remains unexpended from the grant award total of \$1,228,549 provided by the 2020 Federal Emergency Management Agency (FEMA) Urban Search and Rescue (US&R) Task Force Grant Award, for the grant performance period beginning September 1, 2020 through August 31, 2023. The LAFD will front-fund the costs to cover salaries, personnel training, contractual services, travel, supplies and equipment, subject to reimbursement by FEMA upon submission of proper documentation. No matching funds are required. There is no additional impact to the General Fund.

## **FINANCIAL POLICIES STATEMENT**

These actions are in compliance with the City's Financial Policies in that all grant funds will be utilized to fund grant activities.
